- 5 (ii) **1.** The limitation on noneconomic damages provided under subparagraph (i) of this paragraph shall increase by \$15,000 on January 1 of each year [beginning] **BETWEEN** January 1, 2009, **AND DECEMBER 31, 2013**.
- 8 **2.** The increased amount shall apply to causes of action arising between January 1 and December 31 of that year, inclusive.
- 10 (III) EXCEPT AS PROVIDED IN PARAGRAPH (2)(II) OF THIS 11 SUBSECTION, AN AWARD OR A VERDICT UNDER THIS SUBTITLE FOR 12 NONECONOMIC DAMAGES:
