# A BILL ENTITLED

## 1 AN ACT concerning

$\frac{1}{2}$	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
3	Article 2B – Alcoholic Beverages
4	11-517.
5	(a) This section applies only in Prince George's County.
	(b) (1) (i) A holder of any retail "on-sale" alcoholic beverage license or any agent, servant or employee of a holder of any "on-sale" alcoholic beverage license may not sell or serve any alcoholic beverages for consumption on the licensed premises or permit any alcoholic beverages to be consumed on the licensed premises between the hours of 2:00 a.m. and 6:00 a.m., except as provided in subsection (c) of this section.
12 13 14 15	(ii) Holders of any "on-sale" retail alcoholic beverage license, their agents, servants, or employees may sell beer and light wine on Sunday for consumption on the licensed premises, except between the hours of 2:00 a.m. and 8:00 a.m.
16 17 18 19 20	(iii) Subject to paragraph (2) of this subsection, a holder of any Class B restaurant license, with or without [a] AN ON-SALE Sunday permit THAT AUTHORIZES THE HOLDER TO SELL LIQUOR BY THE GLASS, may sell beer, wine and liquor on Sunday when it falls on Christmas Eve or New Year's Eve, except between the hours of 2:00 a.m. and 8:00 a.m.
21 22 23	(2) (ii) A holder of a Class A beer, wine and liquor license or any agent, servant or employee of a holder of a Class A beer, wine and liquor license may not make any sale on Sunday after 12:00 a.m. [except when] UNLESS:

27 28 29 30 31 32 33 34	(f) (1) (I) [Notwithstanding any other provisions of this article, but in addition thereto] EXCEPT AS PROVIDED IN SUBSECTION (L) OF THIS SECTION AND SUBPARAGRAPH (II) OF THIS PARAGRAPH, the holder of a beer, wine and liquor license, Class B, his agents, servants or employees may not sell any alcoholic beverages for consumption off the licensed premises between the hours of 12:00 a.m. and 6:00 a.m. or on Sunday after 12:00 a.m. from any separate store established on the licensed premises as an "off-sale store" or to keep an "off-sale store" open for business on Sunday after 12:00 a.m. [except that beer]

1 (II) **BEER** and light wine only may be sold from an "off-sale" 2 store which is attached to and a part of the licensed premises on Sunday after 8:00 3 a.m. until 12:00 a.m. the day following.

4 (2) (I) For the purpose of this provision, the Board of License 5 Commissioners shall determine by reasonable standards what shall constitute an 6 "off-sale store".

7 (II) Nothing further herein shall be construed to permit sales at 8 any time between 12:00 a.m. and 6:00 a.m. of any day.

9 (L) (1) THERE IS A SPECIAL SUNDAY OFF-SALE PERMIT.

10 (2) THE BOARD OF LICENSE COMMISSIONERS MAY ISSUE THE 11 PERMIT TO A HOLDER OF:

12

(I) ANY CLASS A LICENSE; OR

13(II)A CLASS B BEER, WINE AND LIQUOR LICENSE WITH AN14OFF-SALE PRIVILEGE.

15 (3) THE PERMIT AUTHORIZES THE SALE OF ALCOHOLIC 16 BEVERAGES THAT THE HOLDER IS LICENSED TO SELL:

17 (I) FROM 8:00 A.M. ON SUNDAY TO MIDNIGHT THE 18 FOLLOWING DAY; AND

19(II) FOR CONSUMPTION OFF THE LICENSED PREMISES20ONLY.

21(4)THE ANNUAL PERMIT FEE IS \$450, WHICH IS IN ADDITION TO22THE ANNUAL FEE FOR THE HOLDER'S ALCOHOLIC BEVERAGES LICENSE.

23(5) THE BOARD OF LICENSE COMMISSIONERS MAY ADOPT24REGULATIONS TO CARRY OUT THIS SUBSECTION.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 October 1, 2014.
