## A BILL ENTITLED

1 AN ACT concerning

2 **Education – Federal Elementary and Secondary Education Act – Waivers**

3 FOR the purpose of requiring certain waivers from the federal Elementary and  
4 Secondary Education Act requested by the State Department of Education to  
5 the United States Department of Education to be consistent with State law and  
6 regulations; requiring the Department to adopt certain regulations before  
7 requesting certain waivers; requiring the State Superintendent of Schools to  
8 submit a certain description of how certain waivers are consistent with State  
9 law and regulations, including certain references to certain statutes and  
10 regulations, to the Governor and the General Assembly at least a certain  
11 number of days before requesting certain waivers; and generally relating to the  
12 request for waivers to the United States Department of Education from the  
13 federal Elementary and Secondary Education Act.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
20 MARYLAND, That the Laws of Maryland read as follows:

2 **IF THE DEPARTMENT REQUESTS A WAIVER FROM THE UNITED STATES**  
3 **DEPARTMENT OF EDUCATION FROM SPECIFIC PROVISIONS OF THE FEDERAL**  
4 **ELEMENTARY AND SECONDARY EDUCATION ACT:**

5 **(1) THE DEPARTMENT SHALL ADOPT REGULATIONS**  
6 **ESTABLISHING THE PROVISIONS OF THE WAIVER BEFORE REQUESTING THE**  
7 **WAIVER;**

8 **(2) THE WAIVER SHALL BE CONSISTENT WITH STATE LAW AND**  
9 **REGULATIONS; AND**

10 **(3) AT LEAST 60 DAYS BEFORE REQUESTING THE WAIVER, THE**  
11 **STATE SUPERINTENDENT SHALL SUBMIT TO THE GOVERNOR AND, IN**  
12 **ACCORDANCE WITH § 2-1246 OF THE STATE GOVERNMENT ARTICLE, THE**  
13 **GENERAL ASSEMBLY A DETAILED DESCRIPTION OF HOW THE WAIVER IS**  
14 **CONSISTENT WITH STATE LAW AND REGULATIONS, INCLUDING REFERENCES TO**  
15 **RELEVANT STATUTES AND REGULATIONS.**

16 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**  
17 **June 1, 2014.**
