1 AN ACT concerning

2 **State Board of Morticians and Funeral Directors – Funeral Establishments**
3 **Owned by a Single Owner – Pre-Need Trustee Licenses and Public**
4 **Notification of Death**

5 FOR the purpose of requiring the State Board of Morticians and Funeral Directors to
6 issue an executor license to an applicant if the applicant is the appointed
7 personal representative of a deceased surviving spouse's estate under certain
8 circumstances; requiring a certain personal representative of a surviving
9 spouse's estate to be licensed by the Board; ~~altering the number of days after~~
10 ~~the death of a licensed mortician, funeral director, or surviving spouse that~~
11 ~~certain documentation is required to be submitted to the Board by an applicant~~
12 ~~for an executor license;~~ requiring an applicant for an executor license to submit
13 to the Board, within a certain time period, the name of a licensed funeral
14 director or mortician who has agreed to apply for a certain pre-need trustee
15 license; ~~altering the number of months for which an executor license is valid;~~
16 requiring the Board to provide for the term of an executor license, rather than
17 specifying the term in a certain provision of law; providing that the term of an
18 executor license may not exceed a certain number of months; authorizing the
19 Board to renew an executor license for a certain time period under certain
20 circumstances; establishing a pre-need trustee license; requiring the Board to
21 issue a pre-need trustee license to an applicant under certain circumstances;
22 providing that a pre-need trustee license authorizes the license holder to
23 manage pre-need accounts held by a funeral establishment until the closing or
24 sale of the funeral establishment; establishing the term of a pre-need trustee
25 license; providing that a pre-need trustee license holder may be the supervising

35 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 36 MARYLAND, That the Laws of Maryland read as follows:

 40 director's, **OR SURVIVING SPOUSE'S** estate shall be licensed by the Board before
 41 continuing operation of the mortuary science business.

1 (b) The Board shall issue an executor license to an applicant if the applicant:

2 (1) Is the appointed personal representative of a deceased mortician's
3 [or], funeral director's, **OR SURVIVING SPOUSE'S** estate in accordance with the
4 requirements established in Title 5 of the Estates and Trusts Article;

5 (2) Submits to the Board, within ~~{30}~~ **14** days of the death of the
6 licensed mortician [or], funeral director, [written] **OR SURVIVING SPOUSE:**

7 (I) **WRITTEN** verification of the death of the licensee[, written];

8 (II) **WRITTEN** verification of appointment as a personal
9 representative[, and the]; **AND**

10 (III) **THE** application required by the Board; and

11 ~~(IV)~~ **(3) THE WITHIN 14 DAYS AFTER THE DEATH OF THE**
12 **LICENSED MORTICIAN, FUNERAL DIRECTOR, OR SURVIVING SPOUSE, SUBMITS**
13 **TO THE BOARD THE NAME OF A LICENSED FUNERAL DIRECTOR OR MORTICIAN**
14 **WHO HAS AGREED TO APPLY FOR A PRE-NEED TRUSTEE LICENSE ISSUED**
15 **UNDER § 7-308.2 OF THIS SUBTITLE; AND**

17 (f) **(1) (I)** Notwithstanding the provisions of § 7-314 of this subtitle,

7 **THE BOARD;**

8 **(2) HAS BEEN ACTIVELY LICENSED IN GOOD STANDING BY THE**
9 **BOARD FOR A MINIMUM OF 5 YEARS WHILE WORKING IN A FACILITY THAT HAS**
10 **ACCEPTED PRE-NEED CONTRACTS AND WHO CAN PROVIDE PROOF TO THE**
11 **BOARD THAT THESE SERVICES HAVE BEEN PROVIDED BY THE APPLICANT;**

12 **(3) HAS BEEN APPOINTED AS A PRE-NEED TRUSTEE BY THE**
13 **HOLDER OF AN EXECUTOR LICENSE ISSUED UNDER § 7-308.1 OF THIS**
14 **SUBTITLE;**

15 **(4) IS OF GOOD MORAL CHARACTER; AND**

16 **(5) PAYS THE REQUIRED FEE.**

17 **(B) (1) WHILE A PRE-NEED TRUSTEE LICENSE IS EFFECTIVE, THE**
18 **LICENSE AUTHORIZES THE LICENSE HOLDER TO MANAGE PRE-NEED ACCOUNTS**
19 **HELD BY A FUNERAL ESTABLISHMENT UNTIL THE CLOSING OR SALE OF THE**
20 **FUNERAL ESTABLISHMENT.**

21 **(2) NOTWITHSTANDING THE PROVISIONS OF § 7-314 OF THIS**
22 **SUBTITLE, A PRE-NEED TRUSTEE LICENSE IS VALID FROM THE DATE OF**
23 **ISSUANCE UNTIL THE DATE OF EXPIRATION OF THE LICENSE OF THE EXECUTOR**
24 **WHO APPOINTED THE LICENSE HOLDER AS A PRE-NEED TRUSTEE UNDER**
25 **SUBSECTION (A)(3) OF THIS SECTION.**

26 **(C) THE HOLDER OF A PRE-NEED TRUSTEE LICENSE ISSUED UNDER**
27 **THIS SECTION MAY BE THE SUPERVISING MORTICIAN IN A FUNERAL**
28 **ESTABLISHMENT.**

15 SINGLE OWNER AND SOLE LICENSEE ON ANY WEB SITE MAINTAINED BY THE
16 FUNERAL ESTABLISHMENT.

18 OWNER OF A FUNERAL ESTABLISHMENT, THE PRE-NEED TRUSTEE LICENSED
19 UNDER § 7-308.2 OF THIS SUBTITLE SHALL SEND A LETTER TO ALL PRE-NEED
20 CONTRACT HOLDERS WHO HAVE FUNDS IN TRUST WITH OR AN INSURANCE

22 AVAILABLE UNDER § 7-405 OF THIS TITLE.

24 SUBSECTION SHALL BE RETURNED WITHIN 5 DAYS AFTER RECEIPT AND SHALL
25 INCLUDE THE FULL SIGNATURE OF THE PRE-NEED CONTRACT HOLDER NEXT TO
26 THE OPTION CHOSEN FROM THOSE AVAILABLE UNDER § 7-405 OF THIS TITLE.

 8 SINGLE OWNER AND SOLE LICENSEE OF THE ESTABLISHMENT WHICH THE
 9 LICENSEE PREVIOUSLY OWNED FOR THE MONEY IDENTIFIED UNDER
 10 PARAGRAPH (1) OF THIS SUBSECTION.

11 (3) THE EXECUTOR LICENSED UNDER § 7-308.1 OF THIS
 12 SUBTITLE SHALL TRANSFER ALL MONEY IDENTIFIED IN PARAGRAPH (1) OF THIS
 13 SUBSECTION TO THE ABANDONED PROPERTY OFFICE IN THE OFFICE OF THE
 14 COMPTROLLER IN THE PROPER NAME OF THE BENEFICIARY OR BUYER OF THE
 15 PRE-NEED CONTRACT.

16 (E) ~~WITHIN 45~~ 90 DAYS AFTER THE DEATH OF THE SINGLE OWNER OF A
 17 FUNERAL ESTABLISHMENT, THE PRE-NEED TRUSTEE LICENSED UNDER §
 18 7-308.2 OF THIS SUBTITLE SHALL SEND TO THE BOARD A LIST THAT INCLUDES:

19 (1) THE NAMES OF ALL FUNDED PRE-NEED CONTRACT HOLDERS;

20 (2) THE AMOUNT OF THE FUNDS ENTRUSTED TO THE FUNERAL
 21 ESTABLISHMENT THROUGH A BANK ACCOUNT OR INSURANCE PRODUCT; AND

22 (3) THE LOCATION WHERE THE FUNDS CURRENTLY ARE
 23 MAINTAINED.

24 (F) (1) ~~WITHIN 60~~ 90 DAYS AFTER THE DEATH OF THE SINGLE
 25 OWNER OF A FUNERAL ESTABLISHMENT, THE PRE-NEED TRUSTEE LICENSED
 26 UNDER § 7-308.2 OF THIS SUBTITLE SHALL SEND TO THE BOARD A LIST OF ALL
 27 UNCLAIMED CREMAINS, INCLUDING:

2 **STATE ANATOMY BOARD TO ENSURE PROPER DISPOSITION OF THE CREMAINS.**

3 **(G) THE PRE-NEED TRUSTEE LICENSED UNDER § 7-308.2 OF THIS**
4 **SUBTITLE SHALL SUBMIT TO THE BOARD A DIGITAL IMAGE ON REMOVABLE**
5 **MEDIA OR ON CLOUD-BASED STORAGE THAT INCLUDES:**

6 **(1) ALL SIGNED PRE-NEED CONTRACTS; AND**

7 **(2) ANY ASSOCIATED PAPERWORK DATING FROM THE SIGNING OF**
8 **THE PRE-NEED CONTRACT.**

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
10 October 1, 2014.
