### A BILL ENTITLED

1 AN ACT concerning

#### 2 Anne Arundel County – Orphans' Court Judges – Salary and Pension

- 3 FOR the purpose of altering the annual salary of each judge of the Orphans' Court for Anne Arundel County and the Chief Judge of the Orphans' Court for Anne 4  $\mathbf{5}$ Arundel County; providing that the salary and pension for a judge of the 6 Orphans' Court for Anne Arundel County are subject to an annual 7 cost-of-living adjustment; providing for the calculation of the cost-of-living 8 rate; providing that the cost-of-living rate may not exceed a certain percentage; 9 providing for the application of a zero rate under certain circumstances; providing for the calculation of compensation; providing for the application of 10 this Act; providing that a certain limitation does not apply to a certain 11 12individual; defining certain terms; and generally relating to the Orphans' Court of Anne Arundel County. 13

7SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 8 35 of the Maryland Constitution, this Act may not be construed to extend or apply to 9 the salary or compensation of the judges of the Orphans' Court of Anne Arundel 10 County while serving in a term of office beginning before the effective date of this Act, 11 but the provisions of this Act concerning the salary or compensation of the judges of 12the Orphans' Court of Anne Arundel County shall take effect at the beginning of the next following term of office. This limitation does not apply to an individual appointed 13or elected after the effective date of this Act to fill out an unexpired term. 14

15 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect16 October 1, 2014.
