Election Law - Polling Places - Proof of Identity

- FOR the purpose of requiring an election judge to establish a voter's identity by requiring the voter to present certain proof of identity; requiring the election judge to read the voter's name aloud; requiring a voter to vote a provisional ballot if the voter is unable to provide certain proof of identity; prohibiting a person from knowingly and willfully voting or attempting to vote under a false form of identification; making conforming and clarifying changes; and generally relating to requiring voters to present proof of identity at a polling place.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

1 A voter may take into the polling place any written or (ii) 2 printed material to assist the voter in marking or preparing the ballot. 3 (3)Except as provided in subparagraph (ii) of this paragraph, a voter who requires assistance in marking or preparing the ballot because of a physical 4 disability or an inability to read the English language may choose any individual to 5 6 assist the voter. 7 A voter may not choose the voter's employer or agent of that (ii) 8 employer or an officer or agent of the voter's union to assist the voter in marking the 9 ballot. 10 **(4)** If the voter requires the assistance of another in voting but declines to select an individual to assist, an election judge, in the presence of another 11 12 election judge that represents another political party, shall assist the voter in the 13 manner prescribed by the voter. 14 An individual assisting a voter may not suggest in any way how 15 the voter should vote for a particular ticket, candidate, or position on a question. 16 If a voter requires assistance under paragraph (4) or (5) of this (6) 17 subsection, the election judge shall record, on a form prescribed by the State Board, the name of the voter who required assistance and the name of the individual 18 19 providing assistance to the voter. 20 Except as provided in paragraph (3) or (4) of this subsection, an 21individual over the age of 17 years may not accompany a voter into a voting booth. 2216-201.23 (a) A person may not willfully and knowingly: 24(1) (i) impersonate another person in order to vote or attempt to vote; [or] 25 26 (ii) vote or attempt to vote under a false name; OR 27(III) VOTE OR ATTEMPT TO VOTE UNDER A FALSE FORM OF 28 **IDENTIFICATION**; 29 vote more than once for a candidate for the same office or for the (2)30 same ballot question; 31 vote or attempt to vote more than once in the same election, or vote (3)

- 1 (4) vote in an election district or precinct without the legal authority 2 to vote in that election district or precinct;
- 3 (5) influence or attempt to influence a voter's voting decision through 4 the use of force, threat, menace, intimidation, bribery, reward, or offer of reward;
- 5 (6) influence or attempt to influence a voter's decision whether to go to 6 the polls to cast a vote through the use of force, fraud, threat, menace, intimidation, 7 bribery, reward, or offer of reward; or
- 8 (7) engage in conduct that results or has the intent to result in the 9 denial or abridgement of the right of any citizen of the United States to vote on 10 account of race, color, or disability.
- 11 (b) Except as provided in § 16–1002 of this title, a person who violates this section is guilty of a misdemeanor and on conviction is subject to a fine of not more than \$5,000 or imprisonment for not more than 5 years or both.
