## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Calvert County – Alcoholic Beverages – Volunteer Fire Companies and**  
3 **Fraternal Organizations**

4 FOR the purpose of adding volunteer fire companies and fraternal organizations to the  
5 list of organizations for which a Class C beer, wine and liquor license may be  
6 issued in Calvert County; specifying a certain license fee; altering a certain  
7 license fee; specifying that the license in a volunteer fire company or fraternal  
8 organization allows only for the sale of liquor by the drink and on the premises;  
9 and generally relating to alcoholic beverages in Calvert County.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
21 MARYLAND, That the Laws of Maryland read as follows:

1 **Article 2B – Alcoholic Beverages**

2 6–301.

3 (a) (1) Except as provided in subsection (n) of this section, a Class C beer,  
4 wine and liquor license shall be issued by the license issuing authority of the county in  
5 which the place of business is located. It authorizes the holder to keep for sale and sell  
6 all alcoholic beverages at retail at any club, at the place described in the license, for  
7 consumption on the premises only.

8 (f) (1) This subsection applies only in Calvert County.

9 (2) Licenses may be issued for the following premises:

10 (i) 1. Bona fide yacht clubs, as approved by the Board of  
11 License Commissioners.

12 2. The annual license fee is \$500.

13 (ii) 1. Country clubs.

14 2. The annual license fee is \$1,000.

15 (iii) 1. Bona fide post homes of posts of the American Legion  
16 or Veterans of Foreign Wars.

17 2. The annual license fee is [~~\$500~~] **\$100**.

18 3. The licenses in any post homes of posts of the  
19 American Legion and/or Veterans of Foreign Wars shall allow only for the sale of  
20 liquor by the drink and on the premises.

27 **3. THE LICENSE IN A FRATERNAL ORGANIZATION**  
28 **ALLOWS FOR THE SALE OF LIQUOR BY THE DRINK AND ON THE PREMISES.**

- 1           (3)   (i)    There is a Continuing Care Retirement Community license.
- 2                   (ii)   The license may be issued for a club that:
- 3                           1.   Is composed of residents of a continuing care  
4 retirement community that has obtained a certificate of registration from the State  
5 Department of Aging under Title 10, Subtitle 4 of the Human Services Article;
- 6                           2.   Has at least 50 bona fide members; and
- 7                           3.   Has annual dues that average at least \$5 per member.
- 8                   (iii)   A licensee may keep for sale and sell at retail beer, wine,  
9 and liquor to a member or a guest when accompanied by a member at the place  
10 described in the license.
- 11                   (iv)   The annual license fee is \$500.

12           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
13 July 1, 2014.
