## A BILL ENTITLED

1 AN ACT concerning

2 **Calvert County – Alcoholic Beverages – Bottle Clubs – Prohibitions**

3 FOR the purpose of prohibiting in Calvert County an establishment commonly known  
4 as a bottle club that is not licensed by the Board of License Commissioners from  
5 giving, serving, dispensing, keeping, or allowing to be consumed on its premises  
6 or on premises under its control or possession any alcoholic beverages;  
7 establishing a certain penalty for a violation of this Act; and generally relating  
8 to alcoholic beverages in Calvert County.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
21 MARYLAND, That Section(s) 20–103.1 of Article 2B – Alcoholic Beverages of the  
22 Annotated Code of Maryland be renumbered to be Section(s) 20–103.2.

23 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland  
24 read as follows:

2 (A) THIS SECTION APPLIES ONLY IN CALVERT COUNTY.

3 (B) AN ESTABLISHMENT COMMONLY KNOWN AS A BOTTLE CLUB THAT IS  
4 NOT LICENSED BY THE BOARD OF LICENSE COMMISSIONERS MAY NOT GIVE,  
5 SERVE, DISPENSE, KEEP, OR ALLOW TO BE CONSUMED ON ITS PREMISES OR ON  
6 PREMISES UNDER ITS CONTROL OR POSSESSION ANY ALCOHOLIC BEVERAGES.

7 (C) A PERSON THAT VIOLATES THIS SECTION IS GUILTY OF A  
8 MISDEMEANOR AND ON CONVICTION IS SUBJECT TO A FINE NOT EXCEEDING  
9 \$500.

10 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
11 July 1, 2014.
