A BILL ENTITLED

1 AN ACT concerning

2 **Public Utilities – Fixed Charges for Taxicab Services – Baltimore City**

3 FOR the purpose of authorizing a taxicab permit holder to make a fixed charge for any
4 trip by taxicab between certain locations in Baltimore City or between points
5 within Baltimore City as approved by the Public Service Commission; requiring
6 that a fixed charge made under this Act be calculated on a mileage basis
7 approved by the Commission; and generally relating to fixed charges for taxicab
8 services.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Public Utilities**

17 10–210.

18 (a) (1) A taxicab permit holder shall post in each of its taxicabs a schedule
19 of its fares on a rate card.

20 (2) The rate card shall be printed and arranged in a way that allows a
21 passenger to determine readily the exact fare payable by the passenger.

22 (3) A person may not collect a fare other than a fare appearing on or
23 determinable from the rate card posted in the taxicab.

1 (b) (1) This subsection does not apply to a taxicab operating in the City of
2 Hagerstown.

3 (2) (i) Except as provided in subsection (c) of this section, while in
4 service, each taxicab for which a permit is required shall be equipped with an accurate
5 taximeter that is properly installed and connected.

6 (ii) The taximeter shall be the exclusive means of measuring the
7 charges for service and is subject to inspection and testing by the Commission.

8 (c) (1) A fixed charge may be made for any trip by taxicab between:

9 **(I)** a point within the political subdivision in which the taxicab
10 is normally operated and a point outside of the political subdivision;

11 **(II) THE MARYLAND PORT ADMINISTRATION'S CRUISE**
12 **TERMINAL FACILITIES AND:**

13 1. **FORT MCHENRY;**

14 2. **THE WORLD TRADE CENTER INSTITUTE IN**
15 **BALTIMORE; OR**

16 3. **PENN STATION IN BALTIMORE; OR**

17 **(III) POINTS WITHIN BALTIMORE CITY, AS APPROVED BY**
18 **THE COMMISSION.**

19 (2) **[The] A** fixed charge shall be calculated on a mileage basis that the
20 Commission approves.

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
22 June 1, 2014.
