- [(c)] (E) [At] SUBJECT TO SUBSECTION (B) OF THIS SECTION, AT the request of a principal, a county superintendent may suspend a student for more than 10 school days or expel the student.
- [(d)] (F) (1) [If] SUBJECT TO SUBSECTION (B) OF THIS SECTION, IF a principal finds that a suspension of more than 10 school days or expulsion is warranted, the principal immediately shall report the matter in writing to the county superintendent.
- 10 (2) The county superintendent or the county superintendent's designated representative promptly shall make a thorough investigation of the matter.
- 12 (3) If after the investigation the county superintendent finds that a 13 longer suspension or expulsion is warranted, the county superintendent or the county 14 superintendent's designated representative promptly shall arrange a conference with 15 the student and his parent or guardian.
- 16 (4) The student or the student's parent or guardian promptly shall be 17 given a community resources list provided by the county board in accordance with § 18 7–310 of this subtitle.
- 19 (5) If after the conference the county superintendent or the county superintendent's designated representative finds that a suspension of more than 10 school days or expulsion is warranted, the student or the student's parent or guardian may:
- 23 (i) Appeal to the county board within 10 days after the 24 determination;
- 25 (ii) Be heard before the county board, its designated committee, 26 or a hearing examiner, in accordance with the procedures established under § 6–203 of 27 this article; and
- 28 (iii) Bring counsel and witnesses to the hearing.
- 29 (6) Unless a public hearing is requested by the parent or guardian of 30 the student, a hearing shall be held out of the presence of all individuals except those 31 whose presence is considered necessary or desirable by the board.
- 32 (7) The appeal to the county board does not stay the decision of the 33 county superintendent.
  - (8) The decision of the county board is final.

- 1 [(e)] **(G)** Any student expelled or suspended from school: (1) 2 Shall remain away from the school premises during those (i) 3 hours each school day when the school the student attends is in session; and 4 (ii) May not participate in school sponsored activities. 5 (2)The expelled or suspended student may return to the school 6 premises during the prohibited hours only for attendance at a previously scheduled 7 appointment, and if the student is a minor then only if accompanied by his parent or guardian. 8 9 Any person who violates paragraph (1) or (2) of this subsection is guilty of a misdemeanor and on conviction is subject to a fine not exceeding \$100 for 10 each violation. 11 12 **(4)** If a student has been suspended or expelled, the principal or (i) 13 a designee of the principal may not return the student to the classroom without 14 conferring with the teacher who referred the student to the principal, if the student 15 was referred by a teacher, other teachers as appropriate, other appropriate school 16 personnel, the student, and the student's parent or guardian. 17 If the disruptive behavior results in action less than 18 suspension, the principal or a designee of the principal shall confer with the teacher 19 who referred the student to the principal prior to returning the student to that 20 teacher's classroom. 21(5)A county superintendent may deny attendance to any student who 22is currently expelled from another school system for a length of time equal to that 23 expulsion. 24 A school system shall forward information to another school system relating to the discipline of a student, including information on an expulsion of 25 26 the student, on receipt of the request for information. In this subsection, "firearm" means a firearm as defined in 27 [(f)] **(H)** (1) 18 U.S.C. § 921. 28
  - (2) Except as provided in paragraph (3) of this subsection, if the county superintendent or the superintendent's designated representative finds that a student has brought a firearm onto school property, the student shall be expelled for a minimum of 1 year.
  - (3) The county superintendent may specify, on a case by case basis, a shorter period of expulsion or an alternative educational setting, if alternative educational settings have been approved by the county board, for a student who has brought a firearm onto school property.

- 1 (4) The State Board shall adopt regulations to implement this 2 subsection.
  - [(g)] (I) (1) The discipline of a child with a disability, including the suspension, expulsion, or interim alternative placement of the child for disciplinary reasons, shall be conducted in conformance with the requirements of the Individuals with Disabilities Education Act of the United States Code.
- 7 (2) If a child with a disability is being considered for suspension or 8 expulsion, the child or the child's parent or guardian shall be given a community 9 resources list attached to the procedural safeguards notice required by regulation of 10 the State Board.
- [(h)] (J) (1) This subsection does not apply if the student is referred to the Department of Juvenile Services.
  - (2) If a student violates a State or local law or regulation and during or as a result of the commission of that violation damaged, destroyed, or substantially decreased the value of school property or property of another that was on school property at the time of the violation, as part of a conference on the matter with the student, the student's parent or guardian and any other appropriate person, the principal shall require the student or the student's parent to make restitution.
