## Juvenile Law - Transfer of Cases to Juvenile Court

- 3 FOR the purpose of repealing a provision of law that prohibits a court exercising 4 criminal jurisdiction in a case involving a child to transfer the case to the 5 juvenile court under certain circumstances; making certain conforming changes; 6 and generally relating to juvenile law and the transfer of cases to the juvenile 7 court.


