## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Baltimore City – Special Police Officers and School Police Officers**

3 FOR the purpose of repealing a certain provision of law relating to the appointment of  
4 special police officers in Baltimore City; repealing an obsolete provision of law  
5 relating to Baltimore City school police officers; and generally relating to special  
6 police officers and school police officers in Baltimore City.

10 Article 4 – Public Local Laws of Maryland

11 (1979 Edition and 1997 Supplement, and 2000 Supplement, as amended)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article 4 – Baltimore City**

15 [16–16.

16 The Police Commissioner of Baltimore City is hereby authorized, in the exercise  
17 of his discretion, upon the application of any corporation, association, firm or person in  
18 the City of Baltimore that the said Commissioner may deem responsible, to appoint

1 suitable persons as special police officers to serve without pay from the said City or the  
2 State of Maryland, and the corporation, association, firm or person applying for such  
3 appointment shall be liable for the official misconduct, wrongful or negligent acts of  
4 the officer appointed on such application. Every special police officer appointed under  
5 the provisions this section shall, upon the premises of the corporation, association,  
6 firm or person for which he may have been appointed, but not elsewhere, have power  
7 to preserve the public peace, prevent crime, arrest offenders, protect the rights and  
8 property in and upon such premises as fully as a regular police officer of Baltimore  
9 City. A record of such appointment shall be kept in the office of the said  
10 Commissioner, and any appointments so made may be revoked by the said  
11 Commissioner at any time; and the form of badge to be worn by such special police  
12 officer shall be prescribed by the said Police Commissioner and, additionally, such  
13 special police officers shall wear no uniform which does not have the approval of the  
14 Commissioner. Nothing herein shall be intended to permit private detectives licensed  
15 under the laws of Maryland to act or be appointed under the provisions of this section  
16 as a special police officer.

17 Baltimore City school police officers appointed under this section shall have  
18 power to preserve the public peace, prevent crime, arrest offenders, make arrests or  
19 issue traffic citations for violations of any of the provisions of the Maryland vehicle law  
20 or local traffic laws or regulations, including the parking area regulations adopted by a  
21 principal for school property, protect rights and property in, upon, and in the  
22 immediate vicinity of the premises of schools and other Department of Education  
23 properties as fully as regular police officers of Baltimore City. The Baltimore City  
24 school police officers shall have and enjoy the immunities and defenses of regular  
25 police officers in any suit, civil or criminal, brought against them in consequence of  
26 acts done in their official duties. The provision of this section that appointees there  
27 under shall serve without pay from the City or the State of Maryland shall not apply  
28 to Baltimore City school police officers.]

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
30 July 1, 2014.
