## Public Schools – Cardiopulmonary Resuscitation and Automated External Defibrillator Instruction – Graduation Requirement (Breanna's Law)

5 FOR the purpose of requiring a public school student to complete instruction in 6 cardiopulmonary resuscitation and the use of an automated external 7 defibrillator to graduate from high school beginning with students entering a 8 certain grade in a certain year; requiring each county board of education to 9 provide instruction in cardiopulmonary resuscitation and the use of an automated external defibrillator in certain schools beginning in a certain year, 10 using a certain instructional program, and incorporating certain skills; 11 12 requiring, if the instruction is offered for certification, a certain individual to 13 conduct the instruction; authorizing, if the instruction is not offered for certification, a certain individual to facilitate, provide, or oversee the 14 instruction; requiring the State Department of Education to develop a process to 15 16 monitor the implementation of certain provisions of law; defining certain terms; 17 and generally relating to instruction in cardiopulmonary resuscitation and the use of an automated external defibrillator and high school graduation 18 19 requirements in the State.

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 26 MARYLAND, That the Laws of Maryland read as follows:
