A BILL ENTITLED

1 AN ACT concerning

2 **Calvert County – Salaries of County Officials and County Commissioner**  
3 **Retirement Plan Participation**

4 FOR the purpose of authorizing a County Commissioner of Calvert County to  
5 participate in the Calvert County Employees Retirement Savings Plan; altering  
6 the salaries of the Sheriff of Calvert County, Orphans' Court Judges for Calvert  
7 County, and Calvert County Treasurer; providing for the application of this Act;  
8 and generally relating to the salaries of certain Calvert County officials and the  
9 participation of the County Commissioners of Calvert County in the Calvert  
10 County Employees Retirement Savings Plan.

4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
5 MARYLAND, That the Laws of Maryland read as follows:

6 **Article 5 – Calvert County**

7 2–101.

8 (a) Five County Commissioners comprise the Board of County  
9 Commissioners of Calvert County.

10 (b) (1) The annual salary of the president of the Board is:

11 (I) \$41,500 for calendar year 2006;

12 (II) \$42,500 for calendar year 2007;

13 (III) \$43,500 for calendar year 2008; and

14 (IV) \$44,500 for calendar year 2009 and each subsequent  
15 calendar year.

16 (2) The annual salary of each of the associate members of the Board is:

17 (I) \$39,000 for calendar year 2006;

18 (II) \$40,000 for calendar year 2007;

19 (III) \$41,000 for calendar year 2008; and

20 (IV) \$42,000 for calendar year 2009 and each subsequent  
21 calendar year.

22 (c) Each Commissioner may be reimbursed up to an annual total of \$2,000,  
23 for any reasonable costs incurred by the Commissioner in carrying out the functions of  
24 the office.

25 **(D) A COMMISSIONER MAY PARTICIPATE IN THE CALVERT COUNTY**  
26 **EMPLOYEES RETIREMENT SAVINGS PLAN.**

- 1 (f) (1) (i) The Sheriff of Calvert County shall receive an annual salary  
2 of[:
- 3 1. \$78,000 for calendar year 2006;
  - 4 2. \$81,000 for calendar year 2007;
  - 5 3. \$84,000 for calendar year 2008; and
  - 6 4. \$87,000 for calendar year 2009 and each subsequent  
7 calendar year] **\$90,480.**

### 8 Article – Estates and Trusts

9 2–108.

- 10 (f) (1) Each of the judges of the Court for Calvert County shall receive as  
11 annual compensation the sum of[:
- 12 (i) \$8,000 for calendar year 2006;
  - 13 (ii) \$8,250 for calendar year 2007;
  - 14 (iii) \$8,500 for calendar year 2008; and
  - 15 (iv) \$8,750 for calendar year 2009 and each subsequent calendar  
16 year] **\$8,925.**

- 17 (2) The salary of the Chief Judge is[:
- 18 (i) \$8,200 for calendar year 2006;
  - 19 (ii) \$8,450 for calendar year 2007;
  - 20 (iii) \$8,700 for calendar year 2008; and
  - 21 (iv) \$8,950 for calendar year 2009 and each subsequent calendar  
22 year] **\$9,130.**

- 23 (3) The County Commissioners may provide additional funds for  
24 expenses for the judges.

### 25 Article – Local Government

26 16–202.

1           (a)     The annual salary of the County Treasurer of Calvert County is **[\$51,000]**  
2     **\$52,020.**

3           SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, §  
4     35 of the Maryland Constitution, this Act may not be construed to extend or apply to  
5     the salary or compensation of the Sheriff of Calvert County, Orphans' Court Judges for  
6     Calvert County, or Calvert County Treasurer while serving in a term of office  
7     beginning before the effective date of this Act, but the provisions of this Act concerning  
8     the salary or compensation of the Sheriff of Calvert County, Orphans' Court Judges for  
9     Calvert County, or Calvert County Treasurer shall take effect at the beginning of the  
10    next following term of office. This limitation does not apply to an individual appointed  
11    or elected after the effective date of this Act to fill out an unexpired term.

12           SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
13    October 1, 2014.
