CHAPTER

1 AN ACT concerning

Department of Health and Mental Hygiene – Board of Review – Jurisdiction

3 FOR the purpose of limiting the jurisdiction of the Board of Review of the Department 4 of Health and Mental Hygiene to hear and determine appeals from decisions of 5 the Secretary of Health and Mental Hygiene and units in the Department; 6 authorizing the Board to hear and determine any appeal from a decision of the 7 Secretary in a contested case concerning an individual's eligibility for or 8 participation in certain programs; excluding from the Board's review 9 jurisdiction certain Maryland Medical Assistance Program eligibility decisions 10 delegated by the Secretary to the Maryland Health Benefit Exchange; providing that a person aggrieved by a certain adverse determination subject to review by 11 12 the Board forgo review by the Board and instead petition for judicial review; 13 providing that certain decisions are affirmed if the Board does not issue a decision within a certain period of time after submitting the notice of appeal; 14 providing that any party may seek an appeal from a decision of the Board; 15 16 repealing certain obsolete provisions of law; requiring the Department to study 17 the continued role of the Board and report its findings and recommendations to 18 the Governor and certain committees of the General Assembly on or before a 19 certain date; making conforming changes; and generally relating to the 20 jurisdiction of the Board of Review of the Department of Health and Mental 21 Hygiene.
