1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2008 – Baltimore County –**  
3 **The Emmart–Pierpoint Safe House**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2008  
5 to alter the purpose for which a certain grant may be used; changing the name  
6 of a certain grantee; making this Act an emergency measure; and generally  
7 relating to amending the Maryland Consolidated Capital Bond Loan of 2008.

8 BY repealing and reenacting, with amendments,  
9 Chapter 336 of the Acts of the General Assembly of 2008, as amended by  
10 Chapter 707 of the Acts of the General Assembly of 2009  
11 Section 1(3) Item ZA00(U)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
13 MARYLAND, That the Laws of Maryland read as follows:

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
4 MARYLAND, That:

5 (3) ZA00 MISCELLANEOUS GRANT PROGRAMS

6 (U) [The Emmart–Pierpoint Safe House.] **CHERRY HILL**  
7 **CHURCH.** Provide a grant of \$100,000 to the ~~Board of~~  
8 ~~Directors of The~~ Friends of ***HISTORICAL*** Cherry Hill AUMP,  
9 Inc. for the **ACQUISITION, PLANNING, DESIGN,** construction,  
10 **RECONSTRUCTION,** renovation, **RESTORATION,** and capital  
11 equipping of the [Emmart–Pierpoint Safe House,] **CHERRY**  
12 **HILL CHURCH,** located in Baltimore County. (Baltimore  
13 County) ..... 100,000

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency  
15 measure, is necessary for the immediate preservation of the public health or safety,  
16 has been passed by a ye and nay vote supported by three–fifths of all the members  
17 elected to each of the two Houses of the General Assembly, and shall take effect from  
18 the date it is enacted.
