A BILL ENTITLED

1 AN ACT concerning

2 **Higher Education – Military Dependents – Nonresident Tuition Exemption**

3 FOR the purpose of exempting certain dependents of certain members of the United
4 States armed forces from paying nonresident tuition at a public institution of
5 higher education in the State; and generally relating to tuition charges for certain
6 dependents of certain members of the armed forces.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article – Education**

15 15–106.4.

16 (a) **(1)** This [section] **SUBSECTION** applies to the following individuals:

17 [(1)] **(I)** An active duty member of the United States armed forces;

18 [(2)] The spouse of an active duty member of the United States armed
19 forces;

20 (3) A financially dependent child of an active duty member of the
21 United States armed forces;]

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 [(4)] (II) An honorably discharged veteran of the United States armed
2 forces; or

3 [(5)] (III) A member of the National Guard as defined in §
4 13–405(a)(3) of the Public Safety Article.

5 [(b)] (2) Notwithstanding any other provision of this article, an individual
6 described in [subsection (a)] PARAGRAPH (1) of this [section] SUBSECTION who
7 attends a public institution of higher education in the State is exempt from paying
8 nonresident tuition at a public institution of higher education in this State if:

9 [(1)] (I) The active duty member referred to in [subsection (a)]
10 PARAGRAPH (1)(I) of this [section] SUBSECTION:

11 [(i)] 1. Is stationed in this State;

12 [(ii)] 2. Resides in this State; or

13 [(iii)] 3. Is domiciled in this State;

14 [(2)] (II) The honorably discharged veteran REFERRED TO IN
15 PARAGRAPH (1)(II) OF THIS SUBSECTION presents documentation that the
16 individual:

17 [(i)] 1. Was honorably discharged from the United States
18 armed forces; and

19 [(ii) 1.] 2. A. Resides in this State; or

20 [2.] B. Is domiciled in this State; or

21 [(3)] (III) The National Guard member described in [subsection (a)(5)]
22 PARAGRAPH (1)(III) of this [section] SUBSECTION is a member of the Maryland
23 National Guard and joined or subsequently serves in the Maryland National Guard to:

24 [(i)] 1. Provide a Critical Military Occupational Skill; or

25 [(ii)] 2. Be a member of the Air Force Critical Specialty Code
26 as determined by the National Guard.

27 (B) (1) THIS SUBSECTION APPLIES TO THE FOLLOWING INDIVIDUALS:

28 (I) THE SPOUSE OF AN ACTIVE DUTY OR RETIRED MEMBER
29 OF THE UNITED STATES ARMED FORCES; OR

1 **(II) A FINANCIALLY DEPENDENT CHILD OF AN ACTIVE DUTY**
2 **OR RETIRED MEMBER OF THE UNITED STATES ARMED FORCES.**

3 **[(c) (2)** Notwithstanding any other provision of this article, [a spouse or
4 financially dependent child of an active duty member] **AN INDIVIDUAL DESCRIBED**
5 **IN PARAGRAPH (1) OF THIS SUBSECTION** who enrolls as an entering student in a
6 public institution of higher education [and] **IN THE STATE** is exempt from paying
7 nonresident tuition [under subsection (b) of this section shall continue to be exempt
8 from paying nonresident tuition if:

9 (1) The active duty member no longer meets the requirements of
10 subsection (b)(1) of this section; and

11 (2) The spouse or financially dependent child remains continuously
12 enrolled at the public institution of higher education] **AT A PUBLIC INSTITUTION OF**
13 **HIGHER EDUCATION IN THE STATE REGARDLESS OF WHERE THE ACTIVE DUTY**
14 **OR RETIRED MEMBER IS OR WAS STATIONED, RESIDES, OR IS DOMICILED.**

15 **[(d) (C)** The Commission shall adopt regulations in accordance with Title
16 10, Subtitle 1 of the State Government Article to implement the provisions of this
17 section.

18 **SECTION 2. AND BE IT FURTHER ENACTED,** That this Act shall take effect
19 July 1, 2014.
