11 (II) IF THE INITIAL REGISTRATION IS TERMINATED IN 12 ACCORDANCE WITH § <del>15–703(F)</del> <u>5–704(F)</u> OF THIS SUBTITLE EARLIER THAN 6 13 MONTHS AFTER THE DATE OF REGISTRATION, BEFORE ANY SUBSEQUENT 14 REGISTRATION WITH THE ETHICS COMMISSION; AND

15 (2) ON COMPLETION OF THE INITIAL TRAINING COURSE UNDER
16 ITEM (1) OF THIS SECTION, WITHIN THE 2-YEAR PERIOD FOLLOWING THE DATE
17 OF THE MOST RECENTLY COMPLETED TRAINING COURSE.
