## A BILL ENTITLED

1 AN ACT concerning

2 **Judgeships – Circuit Courts and District Court**

3 FOR the purpose of altering the number of resident judges of the circuit court in  
4 certain counties and Baltimore City; altering the number of resident judges of  
5 the District Court in certain districts; and generally relating to judgeships in  
6 the circuit courts and the District Court.

7 BY repealing and reenacting, with amendments,  
8 Article – Courts and Judicial Proceedings  
9 Section 1–503 and 1–603(b)  
10 Annotated Code of Maryland  
11 (2013 Replacement Volume and 2013 Supplement)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article – Courts and Judicial Proceedings**

15 1–503.

16 (a) In each county in the first seven judicial circuits there shall be the  
17 number of resident judges of the circuit court set forth below, including the judge or  
18 judges provided for by the Constitution:

- 19 (1) Allegany ..... 2
- 20 (2) Anne Arundel..... [12] 13
- 21 (3) Baltimore County ..... [18] 19

4           (3)    District 3 — 6, two to be appointed from Cecil County

5           (4)    District 4 — 6, two to be appointed from Calvert County and three  
6 to be appointed from Charles County

7           (5)    District 5 — [16] **17**

8           (6)    District 6 — [12] **13**

9           (7)    District 7 — 9

10          (8)    District 8 — 13

11          (9)    District 9 — 4

12          (10)   District 10 — 7, two to be appointed from Carroll County and five  
13 to be appointed from Howard County

14          (11)   District 11 — 5, three to be appointed from Frederick County and  
15 two to be appointed from Washington County

16          (12)   District 12 — 3, two to be appointed from Allegany County

17           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
18 July 1, 2014.
