A BILL ENTITLED

1 AN ACT concerning

2 Criminal Procedure – Expungement – Misdemeanor Convictions

FOR the purpose of authorizing a certain person to file a certain petition for expungement of a certain record if the person was convicted of a certain misdemeanor and was under a certain age at the time of the conviction; specifying the time period within which a petition for expungement based on a conviction of a certain misdemeanor may not be filed; making a conforming change; and generally relating to expungement of criminal records.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 15 MARYLAND, That the Laws of Maryland read as follows:

18 (a) A person who has been charged with the commission of a crime, including 19 a violation of the Transportation Article for which a term of imprisonment may be 20 imposed, or who has been charged with a civil offense or infraction, except a juvenile 21 offense, as a substitute for a criminal charge may file a petition listing relevant facts 22 for expungement of a police record, court record, or other record maintained by the 23 State or a political subdivision of the State if:

1 (2) A petition for expungement based on a probation before judgment 2 or a stet with the requirement of drug or alcohol abuse treatment may not be filed 3 earlier than the later of:

4 (i) the date the petitioner was discharged from probation or the 5 requirements of obtaining drug or alcohol abuse treatment were completed; or

6 (ii) 3 years after the probation was granted or stet with the 7 requirement of drug or alcohol abuse treatment was entered on the docket.

8 (3) A petition for expungement based on a nolle prosequi with the 9 requirement of drug or alcohol treatment may not be filed until the completion of the 10 required treatment.

11 (4) A petition for expungement based on a full and unconditional 12 pardon by the Governor may not be filed later than 10 years after the pardon was 13 signed by the Governor.

14 (5) Except as provided in paragraph (2) of this subsection, a petition
15 for expungement based on a stet or a compromise under § 3–207 of the Criminal Law
16 Article may not be filed within 3 years after the stet or compromise.

17 (6) A petition for expungement based on the conviction of a crime 18 under subsection (a)(9) of this section may not be filed within 3 years after the 19 conviction or satisfactory completion of the sentence, including probation, that was 20 imposed for the conviction, whichever is later.

(7) A petition for expungement based on a finding of not criminally
responsible under subsection (a)(9) or (10) of this section may not be filed within 3
years after the finding of not criminally responsible was made by the court.
