5	(a) (1) In this section the following words have the meanings indicated.
6 7 8	(2) "Farm area motor vehicle" means a motor vehicle owned by a farmer and operated only on a farm or on a highway within a [10-mile] <b>25-MILE</b> radius of the farm.
9 10	(3) "Island vehicle" means a motor vehicle, other than a golf cart, operated exclusively on an island that:
11	(i) Is not accessible by a highway;
12	(ii) Does not have State maintained highways; and
13	(iii) Contains less than 20 miles of highways.
14 15 16	(b) If registered with the Administration under this section, every farm area motor vehicle, every island vehicle, and every vehicle that meets the requirements of subsection (d)(1) of this section is a Class K (farm area/island) vehicle.
17 18	(c) Except as provided in subsection (d) of this section, for each Class K (farm area/island) vehicle, the annual registration fee is \$2.50.
19 20	(d) (1) The Administration may issue a temporary registration under this section to a vehicle, other than an island vehicle, that:
21 22 23	(i) Is owned by a resident of another state, or a company operating out of another state, if the individual or company is under contract with a Maryland farmer to conduct seasonal harvesting operations in this State;
24 25	(ii) Is used to transport perishable commodities directly between a farm and a packing plant for sorting and processing;
26 27	(iii) Passes a level 1 safety inspection conducted by the Department of State Police; and

SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three–fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted. It shall remain effective for a period of 5 years from the date it is enacted and, at the end of the 5-year period, with no further action required by the General Assembly, this Act shall be abrogated and of no further force and effect.
