## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Income Tax Refund – Baltimore City – Warrants**

3 FOR the purpose of altering the requirement for the Comptroller to withhold Maryland  
4 income tax refunds from certain individuals with outstanding warrants to include  
5 residents of Baltimore City or individuals who have outstanding warrants from  
6 Baltimore City; providing for the termination of this Act; and generally relating to  
7 withholding income tax refunds from individuals with outstanding warrants.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article – Tax – General**

21 13–935.

22 (a) In this part the following words have the meanings indicated.

23 (b) “Refund” means an individual’s Maryland income tax refund.

- 1 (c) (1) "Warrant" means a criminal arrest warrant.
- 2 (2) "Warrant" includes a warrant issued for or that results from:
- 3 (i) a failure to appear before a court of the State;
- 4 (ii) a violation of the Maryland Vehicle Law that is punishable  
5 by a term of confinement; or
- 6 (iii) a violation of probation.
- 7 (3) "Warrant" does not include a body attachment.
- 8 (d) "Warrant official" means an official of the federal, State, or local  
9 government charged with serving a warrant.

10 13-936.

- 11 (a) This part applies only to individuals who:
- 12 (1) are residents of Anne Arundel County **OR BALTIMORE CITY**; or
- 13 (2) have an outstanding warrant from Anne Arundel County **OR**  
14 **BALTIMORE CITY**.
- 15 (b) This part does not apply to an individual:
- 16 (1) who is an active duty member of the armed forces of the United  
17 States; or
- 18 (2) who files a joint Maryland income tax return.

19 13-937.

20 A warrant official may:

- 21 (1) certify to the Comptroller the existence of an outstanding warrant  
22 for an individual who is a resident of Maryland or who receives income from  
23 Maryland; and
- 24 (2) request the Comptroller to withhold any refund to which the  
25 individual is entitled.

26 13-938.

- 27 (a) A certification by a warrant official to the Comptroller shall include:

1           (1)    the full name and address of the individual and any other names  
2 known to be used by the individual;

3           (2)    the Social Security number or federal tax identification number;  
4 and

5           (3)    a statement that the warrant is outstanding.

6           (b)    The Comptroller shall determine if an individual for whom a certification  
7 is received is due a refund.

8           (c)    As to any individual due a refund for whom a certification is received, the  
9 Comptroller shall:

10           (1)   withhold the individual's refund; and

11           (2)   notify the individual of a certification by the warrant official of the  
12 existence of an outstanding warrant.

13           (d)   The Comptroller may not pay a refund until the warrant official notifies  
14 the Comptroller that the warrant is no longer outstanding.

15 13-939.

16           The Comptroller shall withhold and pay any amount as provided in § 13-918 of  
17 this subtitle before withholding any part of an income tax refund under § 13-938 of  
18 this part.

19 13-940.

20           On or before December 1 of each year, the Office of the Comptroller shall report  
21 to the House Ways and Means Committee and the Senate Budget and Taxation  
22 Committee, in accordance with § 2-1246 of the State Government Article, on the  
23 implementation of §§ 13-935 through 13-939 of this part.

24           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
25 October 1, 2014. It shall remain effective for a period of 5 years and, at the end of  
26 September 30, 2019, with no further action required by the General Assembly, this Act  
27 shall be abrogated and of no further force and effect.
