1 AN ACT concerning

Montgomery County – Alcoholic Beverages – Special BWL Community Performing Arts Facility License

FOR the purpose of establishing a Special BWL Community Performing Arts Facility 4 $\mathbf{5}$ alcoholic beverages license in Montgomery County; authorizing the Montgomery 6 County Board of License Commissioners to issue a Special BWL Community 7 Performing Arts Facility license to apply to a certain performing arts facility; 8 authorizing the Board to issue the license to certain entities to host certain 9 activities; authorizing the Board to impose certain conditions on the issuance or 10 renewal of the license; prohibiting the Board from approving the transfer of the 11 license to another location; authorizing holders of certain catering licenses to 12 bring alcohol and food onto certain licensed premises under the terms of a 13certain contract; providing that certain violations of alcoholic beverages law apply to a certain caterer under certain circumstances; requiring a holder of the 14 license to ensure that food is provided during a certain time; prohibiting the 15Board from issuing more than a certain number of licenses under this Act to a 16 certain entity; establishing a certain license fee; defining a certain term; and 1718 generally relating to alcoholic beverages licenses in Montgomery County.

4 (VI) THE BOARD MAY IMPOSE CONDITIONS ON THE 5 ISSUANCE OR RENEWAL OF THE LICENSE THAT ESTABLISH THE AREAS IN THE 6 COMMUNITY PERFORMING ARTS FACILITY WHERE BEER, WINE, AND LIQUOR 7 MAY BE SOLD, SERVED, POSSESSED, OR CONSUMED.

8 (VII) THE BOARD MAY NOT APPROVE THE TRANSFER OF THE 9 LICENSE TO ANOTHER LOCATION.

10 (VIII) 1. A HOLDER OF A CLASS B-BWLHR LICENSE WITH 11 CATERING AUTHORITY, A MONTGOMERY COUNTY CATERING LICENSE (CAT), 12 OR A STATEWIDE CATERER LICENSE (SCAT) MAY BRING ALCOHOL AND FOOD 13 ON THE LICENSED PREMISES UNDER THE TERMS OF A CONTRACT WITH A 14 HOLDER OF A SPECIAL BWL COMMUNITY PERFORMING ARTS FACILITY 15 LICENSE.

16 2. A VIOLATION OF THIS ARTICLE THAT OCCURS 17 WHEN A CATERER BRINGS ALCOHOL ON LICENSED PREMISES AS PROVIDED 18 UNDER SUBSUBPARAGRAPH 1 OF THIS SUBPARAGRAPH IS THE RESPONSIBILITY 19 OF THE CATERER AND IS NOT THE RESPONSIBILITY OF THE HOLDER OF THE 20 LICENSE.

(IX) A HOLDER OF THE LICENSE SHALL ENSURE THAT FOOD
 IS PROVIDED DURING THE HOURS ALCOHOLIC BEVERAGES ARE SOLD, SERVED,
 POSSESSED, OR CONSUMED.

24(x) THE BOARD MAY ISSUE NO MORE THAN THREE25LICENSES TO A NOT-FOR-PROFIT PARTNERSHIP, A LIMITED LIABILITY26COMPANY, A CORPORATION, OR ANY OTHER ENTITY THAT OWNS OR LEASES27PERFORMING ARTS FACILITIES IN SEPARATE LOCATIONS.

(XI) THE ANNUAL LICENSE FEE IS \$750.
