- 5 (a) An individual who fails to comply with the relief granted in an interim 6 peace order under § 3–1503.1 of this subtitle, a temporary peace order under § 3–1504(a)(2) of this subtitle, or a final peace order under § 3–1505(d)(1)(i), (ii), (iii), or 8 (iv) of this subtitle is guilty of a misdemeanor and on conviction is subject to:
- 9 (1) For a first offense, a fine not exceeding \$1,000 or imprisonment not exceeding 90 days or both; and
- 11 (2) For a second or subsequent offense, a fine not exceeding \$2,500 or 12 imprisonment not exceeding 1 year or both.
