## A BILL ENTITLED

1 AN ACT concerning

2 **Health Occupations – Chiropractors, Massage Therapists, Physical**  
3 **Therapists, and Physical Therapist Assistants – Criminal History Records**  
4 **Checks Required**

5 FOR the purpose of requiring certain applicants to the State Board of Chiropractic and  
6 Massage Therapy Examiners and the State Board of Physical Therapy  
7 Examiners to submit to a certain criminal history records check; requiring  
8 certain applicants to submit certain fingerprints and certain fees to the  
9 Criminal Justice Information System Central Repository of the Department of  
10 Public Safety and Correctional Services under certain circumstances; requiring  
11 the Central Repository to forward to certain boards and certain applicants  
12 certain criminal history record information; authorizing certain boards to accept  
13 certain alternate methods of criminal history records checks under certain  
14 circumstances; providing that certain information is confidential, may not be  
15 redisseminated, and may be used only for certain purposes; authorizing certain  
16 individuals to contest the contents of certain statements issued by the Central  
17 Repository under certain circumstances; requiring the submission of certain  
18 evidence to a certain board as part of a certain application for licensure;  
19 requiring certain boards to consider certain factors in determining whether to  
20 grant certain licenses or registrations on receipt of certain criminal history  
21 record information; prohibiting certain boards from issuing certain licenses or  
22 registrations under certain circumstances; authorizing certain boards to deny  
23 certain licenses or registrations, reprimand or place on probation certain  
24 licensees, or suspend or revoke certain licenses or registrations under certain  
25 circumstances; defining a certain term; and generally relating to requiring  
26 criminal history records checks for chiropractors, massage therapists, physical  
27 therapists, and physical therapist assistants.

17 (1) **SUBMITS TO A CRIMINAL HISTORY RECORDS CHECK IN**  
18 **ACCORDANCE WITH § 3-302.1 OF THIS SUBTITLE;**

19 (2) **MEETS** the requirements of this section; and

20 (3) **MEETS** the examination requirements of this title.

22 (A) **IN THIS SECTION, “CENTRAL REPOSITORY” MEANS THE CRIMINAL**  
23 **JUSTICE INFORMATION SYSTEM CENTRAL REPOSITORY OF THE DEPARTMENT**  
24 **OF PUBLIC SAFETY AND CORRECTIONAL SERVICES.**

25 (B) **AS PART OF AN APPLICATION TO THE CENTRAL REPOSITORY FOR A**  
26 **STATE AND NATIONAL CRIMINAL HISTORY RECORDS CHECK, AN APPLICANT**  
27 **SHALL SUBMIT TO THE CENTRAL REPOSITORY:**

28 (1) **TWO COMPLETE SETS OF LEGIBLE FINGERPRINTS TAKEN ON**  
29 **FORMS APPROVED BY THE DIRECTOR OF THE CENTRAL REPOSITORY AND THE**  
30 **DIRECTOR OF THE FEDERAL BUREAU OF INVESTIGATION;**

1           **(2) THE FEE AUTHORIZED UNDER § 10-221(B)(7) OF THE**  
2 **CRIMINAL PROCEDURE ARTICLE FOR ACCESS TO STATE CRIMINAL HISTORY**  
3 **RECORDS; AND**

4           **(3) THE PROCESSING FEE REQUIRED BY THE FEDERAL BUREAU**  
5 **OF INVESTIGATION FOR A NATIONAL CRIMINAL HISTORY RECORDS CHECK.**

6           **(C) IN ACCORDANCE WITH §§ 10-201 THROUGH 10-228 OF THE**  
7 **CRIMINAL PROCEDURE ARTICLE, THE CENTRAL REPOSITORY SHALL FORWARD**  
8 **TO THE BOARD AND TO THE APPLICANT THE CRIMINAL HISTORY RECORD**  
9 **INFORMATION OF THE APPLICANT.**

10           **(D) IF AN APPLICANT HAS MADE THREE OR MORE UNSUCCESSFUL**  
11 **ATTEMPTS AT SECURING LEGIBLE FINGERPRINTS, THE BOARD MAY ACCEPT AN**  
12 **ALTERNATE METHOD OF A CRIMINAL HISTORY RECORDS CHECK AS PERMITTED**  
13 **BY THE DIRECTOR OF THE CENTRAL REPOSITORY AND THE DIRECTOR OF THE**  
14 **FEDERAL BUREAU OF INVESTIGATION.**

15           **(E) INFORMATION OBTAINED FROM THE CENTRAL REPOSITORY UNDER**  
16 **THIS SECTION:**

17                   **(1) IS CONFIDENTIAL AND MAY NOT BE REDISSEMINATED; AND**

18                   **(2) MAY BE USED ONLY FOR THE LICENSING OR REGISTRATION**  
19 **PURPOSE AUTHORIZED BY THIS TITLE.**

20           **(F) THE SUBJECT OF A CRIMINAL HISTORY RECORDS CHECK UNDER**  
21 **THIS SECTION MAY CONTEST THE CONTENTS OF THE PRINTED STATEMENT**  
22 **ISSUED BY THE CENTRAL REPOSITORY AS PROVIDED IN § 10-223 OF THE**  
23 **CRIMINAL PROCEDURE ARTICLE.**

25           **(a) To apply for a license, an applicant shall submit to the Board at least 45**  
26 **days before an examination:**

27                   **(4) Satisfactory evidence of good moral character; [and]**

28                   **(5) An application fee set by the Board; AND**

29                   **(6) SATISFACTORY EVIDENCE OF HAVING COMPLETED A STATE**  
30 **AND NATIONAL CRIMINAL HISTORY RECORDS CHECK IN ACCORDANCE WITH §**  
31 **3-302.1 OF THIS SUBTITLE.**

2 (a) [The] **SUBJECT TO SUBSECTION (C) OF THIS SECTION, THE Board**  
 3 shall issue a license to any applicant who:

4 (1) Pays a license fee set by the Board; and

5 (2) Otherwise meets the requirements of this title.

6 **(C) (1) ON RECEIPT OF THE CRIMINAL HISTORY RECORD**  
 7 **INFORMATION OF AN APPLICANT FOR LICENSURE OR REGISTRATION**

 9 **SUBTITLE, IN DETERMINING WHETHER TO GRANT A LICENSE OR REGISTRATION,**

12 **(II) THE CIRCUMSTANCES SURROUNDING THE CRIME;**

13 **(III) THE LENGTH OF TIME THAT HAS PASSED SINCE THE**  
 14 **CRIME;**

15 **(IV) SUBSEQUENT WORK HISTORY;**

16 **(V) EMPLOYMENT AND CHARACTER REFERENCES; AND**

17 **(VI) ANY OTHER EVIDENCE THAT DEMONSTRATES WHETHER**  
 18 **THE APPLICANT POSES A THREAT TO THE PUBLIC HEALTH OR SAFETY.**

19 **(2) THE BOARD MAY NOT ISSUE A LICENSE OR REGISTRATION IF**  
 20 **THE CRIMINAL HISTORY RECORD INFORMATION REQUIRED UNDER § 3–302.1 OF**  
 21 **THIS SUBTITLE HAS NOT BEEN RECEIVED.**

22 3–313.

23 Subject to the hearing provisions of § 3–315 of this subtitle, the Board may deny  
 24 a license to any applicant, reprimand any licensee, place any licensee on probation,  
 25 with or without conditions, or suspend or revoke a license, or any combination thereof,  
 26 if the applicant or licensee:

27 (27) Is physically or mentally impaired to the extent that it impairs the  
 28 applicant's or licensee's ability to practice chiropractic safely; [or]

29 (28) Violates any provision of this title; OR

10                           (iv)   Professional ethics; [and]

11                   (5)     Has passed an examination approved by the Board; **AND**

13 **ACCORDANCE WITH § 3-302.1 OF THIS TITLE.**

14           (b)     To qualify for registration, an applicant shall be an individual who:

19                           (iii)  Contraindications to massage therapy; and

20                           (iv)   Professional ethics; [and]

21                   (4)     Has passed an examination approved by the Board; **AND**

22                   **(5) SUBMITS TO A CRIMINAL HISTORY RECORDS CHECK IN**  
23 **ACCORDANCE WITH § 3-302.1 OF THIS TITLE.**

19           **[(2)] (3)** Pay to the Board the application fee set by the Board.

20           (b) To apply for a physical therapist assistant license, an applicant shall:

21           (1) Submit to the Board:

22           (i) An application on the form that the Board requires;

23           (ii) Evidence of completion of:

24                   1. A physical therapist assistant curriculum; and

25                   2. Any clinical training required under the physical  
26 therapist assistant curriculum; and

1 (iii) Any other document that the Board requires; [and]

2 (2) SUBMIT TO A CRIMINAL HISTORY RECORDS CHECK IN  
3 ACCORDANCE WITH § 13-302.1 OF THIS SUBTITLE; AND

4 [(2)] (3) Pay to the Board the application fee set by the Board.

15 (III) THE LENGTH OF TIME THAT HAS PASSED SINCE THE  
16 CRIME;

17 (IV) SUBSEQUENT WORK HISTORY;

19 (VI) ANY OTHER EVIDENCE THAT DEMONSTRATES WHETHER

25 Subject to the hearing provisions of § 13-317 of this subtitle, the Board may  
26 deny a license or restricted license to any applicant, reprimand any licensee or holder  
27 of a restricted license, place any licensee or holder of a restricted license on probation,  
28 or suspend or revoke a license or restricted license if the applicant, licensee, or holder:

29 (24) Willfully and without legal justification, fails to cooperate with a  
30 lawful investigation conducted by the Board; [or]

1                   (25) Fails to meet accepted standards in delivering physical therapy or  
2 limited physical therapy care; **OR**

3                   **(26) FAILS TO SUBMIT TO A CRIMINAL HISTORY RECORDS CHECK**  
4 **IN ACCORDANCE WITH § 13-302.1 OF THIS SUBTITLE.**

6 October 1, 2014.
