## 10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 11 MARYLAND, That the Laws of Maryland read as follows:

### Article – Environment

13 9–342.

(a) In addition to being subject to an injunctive action under this subtitle, a
person who violates any provision of this subtitle or of any rule, regulation, order, or
permit adopted or issued under this subtitle is liable to a civil penalty not exceeding
\$10,000, to be collected in a civil action brought by the Department. Each day a
violation occurs is a separate violation under this subsection.

1 (5) If any person who is liable to pay a penalty imposed under this 2 subsection fails to pay it after demand, the amount, together with interest and any 3 costs that may accrue, shall be:

4 (i) A lien in favor of this State on any property, real or 5 personal, of the person; and

6 (ii) Recorded in the office of the clerk of court for the county in 7 which the property is located.

8 (6) Any penalty collected under this subsection shall be placed in a 9 special fund to be used for monitoring and surveillance by the Department to assure 10 and maintain an adequate record of any violations, including discharge of waste 11 material and other pollutants into the waters of this State or into the environment.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effectOctober 1, 2014.
