FOR the purpose of requiring the State to maintain certain cemeteries in accordance 3 4 with a certain definition certain cemeteries to be provided perpetual care;  $\mathbf{5}$ requiring certain activities or projects to be undertaken in consultation with the 6 Maryland Historical Trust in accordance with certain provisions of law; making 7 certain provisions of State law that apply to property of cemeteries also apply to a cemetery owned by the State and located on the grounds of a State facility; 8 9 requiring the Department of Health and Mental Hygiene, beginning on a certain date and annually thereafter, to report on the implementation of certain 10 11 provisions to certain legislative committees; defining a certain term; altering a 12 certain definition; making a conforming change; and generally relating to 13cemeteries owned by the State and located on the grounds of a State facility.
