CHAPTER _____

1 AN ACT concerning

2 **Frederick County – Gaming Permits**

3 FOR the purpose of increasing the number of gaming events that a certain
4 organization in Frederick County may hold in a calendar year in which the
5 major prize has a value of more than a certain amount; and generally relating to
6 gaming events in Frederick County.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
18 MARYLAND, That the Laws of Maryland read as follows:

19 **Article – Criminal Law**

20 13–1304.

1 (a) Before an organization listed in subsection (b) of this section may conduct
2 a gaming event, the organization shall obtain a permit from the county agency that
3 the county commissioners designate.

4 (b) An organization may conduct a gaming event for its own benefit if the
5 organization is:

6 (1) a bona fide:

7 (i) religious organization;

8 (ii) fraternal organization;

9 (iii) civic organization;

10 (iv) war veterans' organization;

11 (v) hospital;

12 (vi) amateur athletic organization;

13 (vii) patriotic organization;

14 (viii) educational organization; or

15 (ix) charitable organization;

16 (2) a Frederick County volunteer:

17 (i) fire company;

18 (ii) rescue company; or

19 (iii) ambulance company; or

20 (3) an auxiliary for a Frederick County volunteer:

21 (i) fire company;

22 (ii) rescue company; or

23 (iii) ambulance company.

24 (f) (1) The holder of a gaming permit may award:

25 (i) prizes to individuals at a gaming event; and

1 (ii) only one major prize at each gaming event.

2 (2) During each calendar year, the holder of a gaming event, including
3 a raffle for which the prize drawings are held on a single day, may not hold or receive
4 the proceeds from more than [one gaming event] **FOUR GAMING EVENTS** in which the
5 major prize has a value of more than \$5,000.

6 (3) During each calendar year, the holder of a gaming event may hold
7 one raffle in which prize drawings are held on more than a single day if the major
8 prize has a value of \$5,000 or less.

9 (4) The county commissioners may regulate the number of permits to
10 conduct a raffle that an organization may receive in 1 calendar year.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
12 October 1, 2014.
