1 AN ACT concerning

2 **Income Tax – Subtraction Modification – Student Loan Debt**

3 FOR the purpose of allowing a subtraction modification under the Maryland income
4 tax for certain income of certain individuals from the discharge of student loan
5 indebtedness under certain circumstances; requiring an individual to submit
6 certain documentation to qualify for the subtraction modification; providing for
7 the application of this Act; and generally relating to a subtraction modification
8 under the Maryland income tax for certain income from the discharge of certain
9 indebtedness.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article – Tax – General**

4 10–207.

5 (a) To the extent included in federal adjusted gross income, the amounts
6 under this section are subtracted from the federal adjusted gross income of a resident
7 to determine Maryland adjusted gross income.

8 **(BB) (1) THE SUBTRACTION UNDER SUBSECTION (A) OF THIS SECTION**
9 **INCLUDES THE AMOUNT OF STUDENT LOAN INDEBTEDNESS DISCHARGED DUE**
10 **TO TOTAL AND PERMANENT DISABILITY OR DEATH.**

11 **(2) TO QUALIFY FOR THE SUBTRACTION MODIFICATION**
12 **PROVIDED UNDER THIS SUBSECTION, AN INDIVIDUAL MUST ATTACH TO THE**
13 **INDIVIDUAL’S INCOME TAX RETURN OR OTHERWISE FILE WITH THE**
14 **COMPTROLLER A COPY OF THE NOTICE STATING THAT THE LOANS HAVE BEEN**
15 **DISCHARGED DUE TO TOTAL AND PERMANENT DISABILITY OR DEATH.**

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 July 1, 2014, and shall be applicable to all taxable years beginning after December 31,
18 2013.
