## Criminal Procedure - District Court Commissioner - Initial Appearance

- 3 FOR the purpose of prohibiting a commissioner from conducting an initial appearance 4 for an arrested person except during certain time frames with certain exceptions; authorizing a commissioner to conduct an initial appearance for certain arrested persons under certain circumstances; clarifying that the Office of the Public Defender is not required to provide representation to an indigent individual at an initial appearance before a District Court commissioner except 9 during certain time frames; and generally relating to an initial appearance by a District Court commissioner.

13 14 15 16	(a) Representation of an indigent individual may be provided in accordance with this title by the Public Defender or, subject to the supervision of the Public Defender, by the deputy public defender, district public defenders, assistant public defenders, or panel attorneys.
17 18	(b) (1) Indigent defendants or parties shall be provided representation under this title in:
19 20	(i) a criminal or juvenile proceeding in which a defendant or party is alleged to have committed a serious offense;
21 22 23	(ii) a criminal or juvenile proceeding in which an attorney is constitutionally required to be present prior to presentment being made before a commissioner or judge;
24 25	(iii) a postconviction proceeding for which the defendant has a right to an attorney under Title 7 of this article;
