A BILL ENTITLED

1 AN ACT concerning

2 Juveniles – Transfer Determinations – Confinement in Juvenile Facilities

FOR the purpose of requiring a court exercising criminal jurisdiction in a case 3 4 involving a child, or the District Court at a bail review or preliminary hearing, $\mathbf{5}$ to order a certain child to be held in a secure juvenile facility pending a certain 6 transfer determination except under certain circumstances; requiring the 7 District Court at a bail review or preliminary hearing to order that a certain 8 study be made under certain circumstances; and generally relating to the 9 transfer of jurisdiction to the juvenile court and the confinement of juveniles in juvenile facilities. 10

- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 17 MARYLAND, That the Laws of Maryland read as follows:
- **Article Criminal Procedure** 18 4 - 202.19 20(a) In this section the following words have the meanings indicated. (1)21"Victim" has the meaning stated in § 11–104 of this article. (2)"Victim's representative" has the meaning stated in § 11-104 of 22(3)23this article.

4 5	(1) the accused child was at least 14 but not 18 years of age when the alleged crime was committed;
$6 \\ 7$	(2) the alleged crime is excluded from the jurisdiction of the juvenile court under § $3-8A-03(d)(1)$, (4), or (5) of the Courts Article; and
8 9	(3) the court determines by a preponderance of the evidence that a transfer of its jurisdiction is in the interest of the child or society.
10 11	(c) The court may not transfer a case to the juvenile court under subsection(b) of this section if:
12 13	(1) the child previously has been transferred to juvenile court and adjudicated delinquent;

1 (g) If the court transfers its jurisdiction under this section, the court may 2 order the child held for an adjudicatory hearing under the regular procedure of the 3 juvenile court.

4 (h) [Pending a determination under this section to transfer its (1) $\mathbf{5}$ jurisdiction,] IF THE CHILD IS NOT RELEASED ON BAIL, RECOGNIZANCE, OR ON 6 OTHER CONDITIONS OF PRETRIAL RELEASE, the court [may] SHALL order [a] THE 7 child to be held in a secure juvenile facility **PENDING A TRANSFER DETERMINATION** 8 UNDER THIS SECTION UNLESS THE COURT FINDS, BY CLEAR AND CONVINCING 9 EVIDENCE, THAT DETENTION IN A SECURE JUVENILE FACILITY WOULD POSE A 10 SUBSTANTIAL RISK OF HARM TO THE CHILD OR OTHERS.

11 (2) [A hearing on a motion requesting that a child be held in a juvenile 12 facility pending a transfer determination shall be held not later than the next court 13 day, unless extended by the court for good cause shown] IF THE COURT MAKES A 14 FINDING UNDER PARAGRAPH (1) OF THIS SUBSECTION THAT DETENTION IN A 15 SECURE JUVENILE FACILITY WOULD POSE A SUBSTANTIAL RISK OF HARM TO 16 THE CHILD OR OTHERS, THE COURT SHALL STATE THE REASONS FOR THE 17 FINDING ON THE RECORD.

18 (i) (1) A victim or victim's representative shall be given notice of the 19 transfer hearing as provided under § 11–104 of this article.

20 (2) (i) A victim or a victim's representative may submit a victim 21 impact statement to the court as provided in § 11–402 of this article.

(ii) This paragraph does not preclude a victim or victim's
representative who has not filed a notification request form under § 11–104 of this
article from submitting a victim impact statement to the court.

(iii) The court shall consider a victim impact statement in
determining whether to transfer jurisdiction under this section.

(j) (1) [At] REGARDLESS OF WHETHER THE DISTRICT COURT HAS
 CRIMINAL JURISDICTION OVER THE CASE, AT a bail review or preliminary hearing
 before the District Court involving a child whose case is eligible for transfer under
 subsection (b) of this section, the District Court [may] SHALL:

31 (I) ON THE REQUEST OF THE DEFENDANT, order that a study 32 be made under the provisions of subsection (e) of this section [, or that the child be held 33 in a secure juvenile facility under the provisions of subsection (h) of this section, 34 regardless of whether the District Court has criminal jurisdiction over the case]; AND

1(II) ORDER THE CHILD TO BE HELD IN A SECURE JUVENILE2FACILITY PENDING A TRANSFER DETERMINATION UNDER THIS SECTION3UNLESS:

4 **1.** THE CHILD IS RELEASED ON BAIL, 5 RECOGNIZANCE, OR ON OTHER CONDITIONS OF PRETRIAL RELEASE; OR

6 2. THE COURT FINDS BY CLEAR AND CONVINCING
7 EVIDENCE THAT DETENTION IN A SECURE JUVENILE FACILITY WOULD POSE A
8 SUBSTANTIAL RISK OF HARM TO THE CHILD OR OTHERS.

9 (2) IF THE COURT MAKES A FINDING UNDER PARAGRAPH (1)(II)2 10 OF THIS SUBSECTION THAT DETENTION IN A SECURE JUVENILE FACILITY 11 WOULD POSE A SUBSTANTIAL RISK OF HARM TO THE CHILD OR OTHERS, THE 12 COURT SHALL STATE THE REASONS FOR THE FINDING ON THE RECORD.
