BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 MARYLAND. That the Laws of Maryland read as follows: 14 15 **Article - Business Regulation** 5-102.16 The registration and permitting provisions of this title do not apply to: 17 (a) 18 a person that owns and operates a bona fide religious-nonprofit (1) 19 cemetery in this State; 20 a cemetery owned by a not for profit organization created before 1900 by an act of the General Assembly; 21

2	OF THE ACTS OF THE GENERAL ASSEMBLY OF 1852 AND HAS BEEN IN
3	CONTINUOUS EXISTENCE AND OPERATION FOR AT LEAST 150 YEARS;
4 5	[(3)] (4) a county, city, or municipal corporation that owns and operates a cemetery in the State;
6	[(4)] (5) a veterans' cemetery operated by the State; or
7	[(5)] (6) a private family cemetery that does not conduct public sales.
8	(b) This title does not apply to:
9 10	(1) the operation of a funeral establishment, including the sale of burial goods in the ordinary course of the funeral establishment's business;
11 12 13 14	(2) the operation or ownership of a crematory in which a person who is licensed and regulated under Title 7 of the Health Occupations Article owns a greater percentage of the crematory than a registered cemeterian, registered seller, or holder of a permit for the operation of a cemetery or burial goods business;
15 16	(3) the operation or ownership of a crematory or incinerator at a licensed medical facility or educational institution;
17 18	(4) a licensed funeral director acting within the scope of the funeral director's license; or
19	(5) a mortician acting within the scope of the mortician's license.
20 21	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2014 .
