

Private Passenger Motor Vehicle Liability Insurance – Underinsured Motorist Excess Coverage

FOR the purpose of providing for a certain alternative limitation on certain liability 4 $\mathbf{5}$ for an insurer that provides certain uninsured motorist coverage under certain 6 circumstances; requiring certain insurers to offer certain underinsured motorist 7 excess coverage under certain circumstances; providing for the characteristics of 8 that underinsured motorist excess coverage, including what the coverage 9 protects, how the coverage obligates the issuer, and how the selection of the coverage applies to certain policies and endorsements; providing for waivers of 10 certain coverage in certain manners under certain circumstances; establishing a 11 12certain exception to a certain limitation on duplicate or supplemental recovery 13 of certain benefits; defining a certain term; providing for the application of this Act; and generally relating to private passenger motor vehicle liability 14insurance and underinsured motorist excess coverage. 15

8 (2) FOR WHICH THE SUM OF PAYMENTS RECEIVED BY OR ON 9 BEHALF OF THE INSURED FROM OR ON BEHALF OF THE OWNER OR OPERATOR 10 OF THE MOTOR VEHICLE IS LESS THAN THE FAIR, JUST, AND REASONABLE 11 DAMAGES SUSTAINED BY THE INSURED.

12 (B) (1) EACH INSURER THAT ISSUES, SELLS, OR DELIVERS MOTOR 13 VEHICLE LIABILITY INSURANCE IN THE STATE SHALL OFFER UNDERINSURED 14 MOTORIST EXCESS COVERAGE WITH LIMITS THAT AT LEAST EQUAL THE 15 AMOUNTS REQUIRED BY TITLE 17 OF THE TRANSPORTATION ARTICLE.

16(2) THE UNDERINSURED MOTORIST EXCESS COVERAGE SHALL17REQUIRE AN ADDITIONAL PREMIUM.

18(3) AN INSURED MAY PURCHASE UNDERINSURED MOTORIST19EXCESS COVERAGE INSTEAD OF THE UNINSURED MOTORIST COVERAGE20REQUIRED UNDER TITLE 17 OF THE TRANSPORTATION ARTICLE.

(C) UNDERINSURED MOTORIST EXCESS COVERAGE UNDER THIS
 SECTION SHALL PROVIDE PROTECTION FOR INSURED PERSONS WHO ARE
 LEGALLY ENTITLED TO RECOVER DAMAGES FROM THE OWNER OR OPERATOR
