## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **State Board of Nursing – Nurses, Nursing Assistants, Medication**  
3 **Technicians, and Electrologists – Licensing, Certification, Regulation,**  
4 **Violations, and Penalties**

5 FOR the purpose of requiring the State Board of Nursing to establish, on or before a  
6 certain date, a certain program through which the Criminal Justice Information  
7 System Central Repository reports to the Board certain criminal history  
8 information for certain applicants; requiring the Board to notify certain  
9 applicants that certain fingerprints will be retained by the Central Repository  
10 and certain criminal information will be reported to the Board; authorizing the  
11 Board to enter into a certain agreement; establishing requirements for the  
12 Board to place certain licensees and certificate holders on inactive status and to  
13 reactivate certain licenses and certificates if certain documentation of a medical  
14 condition is submitted to the Board; altering the duration of a certain  
15 application for inactive status; prohibiting the Board from charging a certain  
16 fee; providing that a certain inactive status may not be considered certain  
17 disciplinary action or reported to certain entities, employers, or insurance  
18 companies as certain disciplinary action; providing that certain licenses expire  
19 on a certain day; repealing certain prohibitions on the lapsing of certain licenses  
20 and certificates under certain circumstances; authorizing the Board to require  
21 terms on certain agreements to accept the surrender of certain licenses and  
22 certificates; providing that agreements to accept the surrender of certain  
23 licenses and certificates are final orders and public records; clarifying that the  
24 Board may deny or grant licenses or certificates subject to certain reprimand,  
25 probation, or suspension under certain circumstances; altering and adding

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article – Health Occupations**

4 8–101.

5 (a) In this title the following words have the meanings indicated.

6 (b) “Advanced practice nurse” means an individual who:

7 (1) Is licensed by the Board to practice registered nursing; and

8 (2) Is certified by the Board to practice as:

9 (i) A nurse practitioner;

10 (ii) A nurse anesthetist;

11 (iii) A nurse midwife;

12 (iv) A nurse psychotherapist; or

13 (v) A clinical nurse specialist.

14 (c) “APPLICANT” MEANS, UNLESS THE CONTEXT REQUIRES  
15 OTHERWISE:

16 (1) AN INDIVIDUAL APPLYING FOR AN INITIAL LICENSE BY  
17 EXAMINATION OR ENDORSEMENT;

18 (2) A LICENSEE APPLYING FOR RENEWAL OF A LICENSE; OR

19 (3) AN INDIVIDUAL APPLYING FOR REINSTATEMENT OF A  
20 LICENSE IN ACCORDANCE WITH § 8–319 OF THIS TITLE.

21 [(c)] (D) “Board” means the State Board of Nursing.

22 (E) “EXPIRED LICENSE” MEANS, UNLESS THE CONTEXT REQUIRES  
23 OTHERWISE, A LICENSE THAT WAS NOT RENEWED BEFORE THE EXPIRATION  
24 DATE OF THE LICENSE AS ESTABLISHED UNDER § 8–312(A) OF THIS TITLE.

25 (F) “LAPSED LICENSE” MEANS, UNLESS THE CONTEXT REQUIRES  
26 OTHERWISE, A LICENSE THAT WAS NOT RENEWED BECAUSE A LICENSEE FAILED  
27 TO RENEW THE LICENSE OR OTHERWISE DID NOT MEET THE RENEWAL  
28 REQUIREMENTS OF THIS TITLE.

1           **[(d)] (G)**     “License” means, unless the context requires otherwise, a license  
2 issued by the Board to practice:

3                   (1)     Registered nursing; or

4                   (2)     Licensed practical nursing.

5           **[(e)] (H)**     “Licensed practical nurse” means, unless the context requires  
6 otherwise, an individual who is licensed by the Board to practice licensed practical  
7 nursing.

8           **(I)**     **“LICENSEE” MEANS, UNLESS THE CONTEXT REQUIRES OTHERWISE,**  
9 **A REGISTERED NURSE OR LICENSED PRACTICAL NURSE WHO HAS:**

10                   **(1)     AN ACTIVE LICENSE;**

11                   **(2)     AN INACTIVE LICENSE;**

12                   **(3)     A TEMPORARY LICENSE;**

13                   **(4)     AN EXPIRED TEMPORARY LICENSE;**

14                   **(5)     AN EXPIRED LICENSE;**

15                   **(6)     A LAPSED LICENSE;**

16                   **(7)     A SUSPENDED LICENSE; OR**

17                   **(8)     A LICENSE SUBJECT TO A REPRIMAND, PROBATION, OR**  
18 **SUSPENSION.**

19           **[(f)] (J)**     “Nurse practitioner” means an individual who:

20                   (1)     Is licensed by the Board to practice registered nursing; and

21                   (2)     Is certified by the Board to practice as a nurse practitioner.

22           **[(g)] (K)**     “Practice as a nurse practitioner” means to independently:

23                   (1)     Perform an act under subsection **[(i)] (M)** of this section;

24                   (2)     Conduct a comprehensive physical assessment of an individual;

25                   (3)     Establish a medical diagnosis for common chronic stable or  
26 short-term health problems;

- 1 (4) Order, perform, and interpret laboratory tests;
- 2 (5) Prescribe drugs as provided under § 8–508 of this title;
- 3 (6) Perform diagnostic, therapeutic, or corrective measures;
- 4 (7) Refer an individual to an appropriate licensed physician or other  
5 health care provider; and
- 6 (8) Provide emergency care.

7 **[(h)] (L)** “Practice licensed practical nursing” means to perform in a team  
8 relationship an act that requires specialized knowledge, judgment, and skill based on  
9 principles of biological, physiological, behavioral, or sociological science to:

- 10 (1) Administer treatment or medication to an individual;
- 11 (2) Aid in the rehabilitation of an individual;
- 12 (3) Promote preventive measures in community health;
- 13 (4) Give counsel to an individual;
- 14 (5) Safeguard life and health;
- 15 (6) Teach or supervise; or
- 16 (7) Perform any additional acts authorized by the Board under §  
17 8–205 of this title.

18 **[(i)] (M)** (1) “Practice registered nursing” means the performance of acts  
19 requiring substantial specialized knowledge, judgment, and skill based on the  
20 biological, physiological, behavioral, or sociological sciences as the basis for  
21 assessment, nursing diagnosis, planning, implementation, and evaluation of the  
22 practice of nursing in order to:

- 23 (i) Maintain health;
- 24 (ii) Prevent illness; or
- 25 (iii) Care for or rehabilitate the ill, injured, or infirm.
- 26 (2) For these purposes, “practice registered nursing” includes:
  - 27 (i) Administration;

- 1 (ii) Teaching;
- 2 (iii) Counseling;
- 3 (iv) Supervision, delegation and evaluation of nursing practice;
- 4 (v) Execution of therapeutic regimen, including the  
5 administration of medication and treatment;
- 6 (vi) Independent nursing functions and delegated medical  
7 functions; and
- 8 (vii) Performance of additional acts authorized by the Board  
9 under § 8–205 of this title.

10 **[(j)] (N)** “Registered nurse” means, unless the context requires otherwise,  
11 an individual who is licensed by the Board to practice registered nursing.

12 8–303.

13 (a) In this section, “Central Repository” means the Criminal Justice  
14 Information System Central Repository of the Department of Public Safety and  
15 Correctional Services.

16 (b) As part of an application to the Central Repository for a State and  
17 national criminal history records check, an applicant shall submit to the Central  
18 Repository:

19 (1) Two complete sets of legible fingerprints taken on forms approved  
20 by the Director of the Central Repository and the Director of the Federal Bureau of  
21 Investigation;

22 (2) The fee authorized under § 10–221(b)(7) of the Criminal Procedure  
23 Article for access to State criminal history records; and

24 (3) The processing fee required by the Federal Bureau of Investigation  
25 for a national criminal history records check.

26 (c) In accordance with §§ 10–201 through 10–228 of the Criminal Procedure  
27 Article, the Central Repository shall forward to the Board and to the applicant the  
28 criminal history record information of the applicant.

29 **(D) (1) BEGINNING JANUARY 1, 2015, THE BOARD SHALL ESTABLISH**  
30 **A RAP BACK PROGRAM THROUGH WHICH THE CENTRAL REPOSITORY REPORTS**  
31 **ALL NEW AND ADDITIONAL CRIMINAL HISTORY INFORMATION TO THE BOARD**

1 FOR AN APPLICANT WHO HAS BEEN FINGERPRINTED IN ACCORDANCE WITH THE  
2 REQUIREMENTS OF THIS SECTION.

3 (2) THE BOARD SHALL NOTIFY EACH APPLICANT THAT:

4 (I) THE APPLICANT'S FINGERPRINTS WILL BE RETAINED BY  
5 THE CENTRAL REPOSITORY; AND

6 (II) ALL NEW AND ADDITIONAL CRIMINAL INFORMATION  
7 WILL BE REPORTED TO THE BOARD.

8 (3) THE BOARD MAY ENTER INTO AN AGREEMENT WITH THE  
9 CENTRAL REPOSITORY AND THE FEDERAL BUREAU OF INVESTIGATION TO  
10 CARRY OUT THIS SUBSECTION.

11 [(d)] (E) If an applicant has made two or more unsuccessful attempts at  
12 securing legible fingerprints, the Board may accept an alternate method of criminal  
13 history records check as permitted by the Director of the Central Repository and the  
14 Director of the Federal Bureau of Investigation.

15 [(e)] (F) Information obtained from the Central Repository under this  
16 section shall be:

17 (1) Confidential and may not be disseminated; and

18 (2) Used only for the licensing purpose authorized by this title.

19 [(f)] (G) The subject of a criminal history records check under this section  
20 may contest the contents of the printed statement issued by the Central Repository as  
21 provided in § 10-223 of the Criminal Procedure Article.

22 8-309.

23 (a) If an individual has been licensed by the Board to practice registered  
24 nursing or licensed practical nursing in this State in accordance with the  
25 requirements of this subtitle, the individual may be subsequently licensed as a  
26 registered nurse or as a licensed practical nurse on inactive status.

27 (b) The Board shall place a licensee on inactive status and record the  
28 inactive status in the Board's database and on the Board's website if the licensee:

29 (1) (i) Has not satisfactorily completed 1,000 hours of active  
30 nursing practice within the 5-year period immediately preceding the date of  
31 anticipated renewal; [or]

32 (ii) Chooses inactive status; OR

1                   **(III) SUBMITS DOCUMENTATION OF A MEDICAL CONDITION**  
2 **THAT THE BOARD DETERMINES WILL PREVENT THE LICENSEE FROM**  
3 **PRACTICING AS A REGISTERED NURSE OR LICENSED PRACTICAL NURSE;**

4                   (2)   **(I)**    Completes the [annual] **BIENNIAL** application for inactive  
5 status; and

6                   **(II) IF APPLICABLE, PROVIDES DOCUMENTATION OF A**  
7 **CONTINUING MEDICAL CONDITION; AND**

8                   (3)    Pays the [fee established] **APPLICABLE FEES AS REQUIRED** by  
9 the Board.

10           (c)    A licensee on inactive status may not practice nursing in this State, but:

11                   (1)    A registered nurse on inactive status may use the title “Registered  
12 Nurse”, or the abbreviation “RN”; and

13                   (2)    A practical nurse on inactive status may use the title “Licensed  
14 Practical Nurse”, or the abbreviation “LPN”.

15           (d)    **(1)**    [If a] **A** licensee on inactive status [applies a] **MAY APPLY** for  
16 **REACTIVATION OF THE** license to practice nursing [and meets] **IF THE LICENSEE:**

17                   **(I)**    **MEETS** the renewal requirements of § 8–312 of this  
18 subtitle[.]; **AND**

19                   **(II) IF APPLICABLE, SUBMITS DOCUMENTATION**  
20 **SATISFACTORY TO THE BOARD THAT THE MEDICAL CONDITION FOR WHICH THE**  
21 **INACTIVE STATUS WAS GRANTED NO LONGER EXISTS.**

22                   **(2)**    **IF A LICENSEE MEETS THE REQUIREMENTS OF PARAGRAPH**  
23 **(1) OF THIS SUBSECTION,** the Board shall:

24                   [(1)    Remove the licensee from inactive status;

25                   (2)    Void the licensee’s inactive status registration certificate; and]

26                   **(I)**    **RECORD THE STATUS OF THE LICENSEE AS ACTIVE IN**  
27 **THE BOARD’S DATABASE AND ON THE BOARD’S WEB SITE; AND**

28                   [(3)] **(II)**    [Renew] **REACTIVATE** the licensee’s license to practice  
29 nursing in this State.



1           **(E) (1) IF A LICENSEE IS GRANTED INACTIVE STATUS BECAUSE OF A**  
2 **MEDICAL CONDITION, THE BOARD MAY NOT CHARGE A FEE TO PLACE THE**  
3 **LICENSEE ON OR REMOVE THE LICENSEE FROM INACTIVE STATUS.**

4           **(2) IF A LICENSEE IS GRANTED INACTIVE STATUS BECAUSE OF A**  
5 **MEDICAL CONDITION, THE INACTIVE STATUS:**

6                   **(I) MAY NOT BE CONSIDERED A DISCIPLINARY ACTION**  
7 **UNDER § 8-316 OF THIS SUBTITLE; AND**

8                   **(II) MAY NOT BE REPORTED TO ANY CERTIFYING ENTITY,**  
9 **EMPLOYER, OR INSURANCE COMPANY AS A DISCIPLINARY ACTION.**

10 8-312.

11           (a) [(1) On or before December 31, 2012, a] **A** license expires on the 28th  
12 day of the birth month of the licensee[, unless the license is renewed for a 1-year term  
13 as provided in this section.

14                   (2) On or after January 1, 2013, a license expires on the date set by  
15 the Board] and may not be renewed for a term longer than 2 years.

16           (g) (1) (i) Beginning July 2009, the Board shall begin a process  
17 requiring criminal history records checks in accordance with § 8-303 of this subtitle  
18 on:

19                                 1. Selected annual renewal applicants as determined by  
20 regulations adopted by the Board; and

21                                 2. Each [former] licensee who files for reinstatement  
22 under § 8-313 of this subtitle after failing to renew the license for a period of 1 year or  
23 more.

24                                 (ii) An additional criminal history records check shall be  
25 performed every 12 years thereafter.

26 8-313.

27           The Board shall reinstate the license of a [former] licensee who has failed to  
28 renew the license for any reason if the [former] licensee meets the renewal  
29 requirements of § 8-312 of this subtitle.

30 8-314.

31           (a) Unless the Board agrees to accept the surrender of a license, a licensed  
32 registered nurse, licensed practical nurse, or holder of a temporary license may not

1 surrender the license [nor may the license lapse by operation of law while the licensee  
2 is under investigation or while charges are pending against the licensee].

3 (b) The Board may [set] **REQUIRE TERMS AND** conditions on [its] **AN**  
4 agreement with the licensee [under investigation or against whom charges are  
5 pending] to accept surrender of the license.

6 (c) **AN AGREEMENT TO ACCEPT THE SURRENDER OF A LICENSE IS A**  
7 **FINAL ORDER OF THE BOARD AND IS A PUBLIC RECORD.**

8 8–316.

9 (a) Subject to the hearing provisions of § 8–317 of this subtitle, the Board  
10 may deny a license or grant a [probationary] license, **INCLUDING A LICENSE**  
11 **SUBJECT TO A REPRIMAND, PROBATION, OR SUSPENSION**, to any applicant,  
12 reprimand any licensee, place any licensee on probation, or suspend or revoke the  
13 license of a licensee if the applicant or licensee:

14 (1) Fraudulently or deceptively obtains or attempts to obtain a license  
15 for the applicant or for another;

16 (2) Fraudulently or deceptively uses a license;

17 (3) Is disciplined by a licensing, military, or disciplinary authority in  
18 this State or in any other state or country or convicted or disciplined by a court in this  
19 State or in any other state or country for an act that would be grounds for disciplinary  
20 action under the Board’s disciplinary statutes;

21 (4) Is convicted of or pleads guilty or nolo contendere to a felony or to a  
22 crime involving moral turpitude, whether or not any appeal or other proceeding is  
23 pending to have the conviction or plea set aside;

24 (5) Willfully and knowingly:

25 (i) Files a false report or record of an individual under the  
26 licensee’s care;

27 (ii) Gives any false or misleading information about a material  
28 matter in an employment application;

29 (iii) Fails to file or record any health record that is required by  
30 law;

31 (iv) Obstructs the filing or recording of any health record as  
32 required by law; or

1 (v) Induces another person to fail to file or record any health  
2 record as required by law;

3 (6) Knowingly does any act that has been determined by the Board, in  
4 its rules and regulations, to exceed the scope of practice authorized to the individual  
5 under this title;

6 (7) Provides professional services while:

7 (i) Under the influence of alcohol; or

8 (ii) Using any narcotic or controlled dangerous substance, as  
9 defined in § 5–101 of the Criminal Law Article, or other drug that is in excess of  
10 therapeutic amounts or without valid medical indication;

11 (8) Does an act that is inconsistent with generally accepted  
12 professional standards in the practice of registered nursing or licensed practical  
13 nursing;

14 (9) Is grossly negligent in the practice of registered nursing or licensed  
15 practical nursing;

16 (10) Has violated any provision of this title;

17 (11) Submits a false statement to collect a fee;

18 (12) Is physically or mentally incompetent;

19 (13) Knowingly fails to report suspected child abuse in violation of §  
20 5–704 of the Family Law Article;

21 (14) Refuses, withholds from, denies, or discriminates against an  
22 individual with regard to the provision of professional services for which the licensee is  
23 licensed and qualified to render because the individual is HIV positive;

24 (15) Except in an emergency life–threatening situation where it is not  
25 feasible or practicable, fails to comply with the Centers for Disease Control and  
26 Prevention’s guidelines on universal precautions;

27 (16) Is in independent practice and fails to display the notice required  
28 under § 8–506 of this title;

29 (17) Is in breach of a service obligation resulting from the applicant’s or  
30 licensee’s receipt of State or federal funding for the applicant’s or licensee’s nursing  
31 education;

32 (18) Is habitually intoxicated;

1 (19) Is addicted to, or habitually abuses, any narcotic or controlled  
2 dangerous substance as defined in § 5–101 of the Criminal Law Article;

3 (20) Fails to cooperate with a lawful investigation conducted by the  
4 Board;

5 (21) Is expelled from the rehabilitation program established pursuant  
6 to § 8–208 of this title for failure to comply with the conditions of the program;

7 (22) Delegates nursing acts or responsibilities to an individual that the  
8 applicant or licensee knows or has reason to know lacks the ability or knowledge to  
9 perform;

10 (23) Delegates to an unlicensed individual nursing acts or  
11 responsibilities the applicant or licensee knows or has reason to know are to be  
12 performed only by a registered nurse or licensed practical nurse;

13 (24) Fails to properly supervise individuals to whom nursing acts or  
14 responsibilities have been delegated;

15 (25) Engages in conduct that violates the professional code of ethics;

16 (26) Is professionally incompetent;

17 (27) Practices registered nursing or licensed practical nursing without a  
18 license before obtaining or renewing a license, including any period when [the license  
19 or a temporary license of the applicant or licensee has lapsed] **PRACTICING**  
20 **REGISTERED NURSING OR LICENSED PRACTICAL NURSING ON AN EXPIRED**  
21 **LICENSE OR A LAPSED LICENSE;**

22 (28) [After failing to renew a license] **WHEN HOLDING AN EXPIRED**  
23 **LICENSE OR A LAPSED LICENSE** or after a temporary license has [lapsed] **EXPIRED**  
24 **IN ACCORDANCE WITH § 8–315(D) OF THIS SUBTITLE**, commits any act that would  
25 be grounds for disciplinary action under this section;

26 (29) Practices registered nursing or licensed practical nursing on a  
27 nonrenewed license for a period of 16 months or longer;

28 (30) Violates regulations adopted by the Board or an order from the  
29 Board;

30 (31) Performs an act that is beyond the licensee's knowledge and skills;

31 (32) Fails to submit to a criminal history records check in accordance  
32 with § 8–303 of this subtitle;

1           (33) When acting in a supervisory position, directs another nurse to  
2 perform an act that is beyond the nurse's knowledge and skills; [or]

3           (34) When acting in a supervisory position, directs another nurse to  
4 delegate a nursing task to an individual when that nurse reasonably believes:

5                   (i) The individual lacks the knowledge and skills to perform the  
6 task; or

7                   (ii) The patient's condition does not allow delegation of the  
8 nursing task; **OR**

9           **(35) HAS MISAPPROPRIATED THE PROPERTY OF A PATIENT OR A**  
10 **FACILITY.**

11           (b) If, after a hearing under § 8-317 of this subtitle, the Board finds that  
12 there are grounds under subsection (a) of this section to suspend or revoke a license to  
13 practice registered nursing or licensed practical nursing, to reprimand a licensee, or  
14 place a licensee on probation, the Board may impose a penalty not exceeding \$5,000  
15 instead of or in addition to suspending or revoking the license, reprimanding the  
16 licensee, or placing the licensee on probation.

17           [(c) An individual whose license has been suspended or revoked by the Board  
18 shall return the license to the Board. However, if the suspended or revoked license has  
19 been lost, the individual shall file with the Board a verified statement to that effect.]
