3 **Member Rights**

4 FOR the purpose of requiring certain meetings of a cooperative housing corporation to
5 be open to the members of the cooperative housing corporation; requiring that
6 members be given reasonable notice of certain meetings of the cooperative
7 housing corporation; requiring the governing body of a cooperative housing
8 corporation to provide a designated period of time during a meeting to allow
9 members an opportunity to comment on certain matters, subject to certain rules
10 and provisions of law; ~~requiring the governing body of a cooperative housing~~
11 ~~corporation to convene a certain number of meetings each year at which the~~
12 ~~agenda is open to any matter relating to the cooperative housing corporation;~~
13 specifying the reasons for which a cooperative housing corporation may hold a
14 meeting in closed session; placing certain limitations on the actions that may be
15 taken at a closed meeting of a cooperative housing corporation; requiring the

32 [(c)] (d) “Blanket encumbrance” means any contract binding on a
 33 cooperative housing corporation and creating a lien or security interest or other
 34 encumbrance or imposing restrictions on any real or personal property owned by the
 35 cooperative housing corporation.

1 [(d)] (E) “Bylaws” means the document which details and governs the
2 internal organization and operation of the cooperative housing corporation.

3 [(e)] (F) “Conversion” means the creation of a cooperative housing
4 corporation from a property which was immediately previously a residential rental
5 facility.

6 [(f)] (G) “Cooperative housing corporation” means a domestic or foreign
7 corporation qualified in this State, either stock or nonstock, having only one class of
8 stock or membership, in which each stockholder or member, by virtue of such
9 ownership or membership, has a cooperative interest in the corporation.

10 [(g)] (H) “Cooperative interest” means the ownership interest in a
11 cooperative housing corporation which is coupled with a possessory interest in real or
12 personal property or both and evidenced by a membership certificate.

13 [(h)] (I) “Cooperative project” means all the real and personal property in
14 this State owned or leased by the cooperative housing corporation for the primary
15 purpose of residential use.

21 (i) Owns an equitable interest, including a cooperative interest,
22 in a unit prior to its initial sale to a member of the public;

23 (ii) Exercises control over cooperative interests before they are
24 transferred to initial purchasers, excluding management agents and sales agents
25 acting in their capacities as such; or

26 (iii) Receives a material portion of the sales proceeds, not
27 including customary brokerage commissions or payment for indebtedness to an
28 institutional banker, from the initial sale of a cooperative interest to a member of the
29 public.

30 (2) “Developer” does not include a cooperative housing corporation.

31 [(j)] ~~(H)~~ (K) “Electronic transmission” means any form of communication, not
32 directly involving the physical transmission of paper, that creates a record that:

1 (1) May be retained, retrieved, and reviewed by a recipient of the
2 communication; and

3 (2) May be reproduced directly in paper form by a recipient through an
4 automated process.

5 ~~(M)~~ (L) “GOVERNING BODY” MEANS THE BOARD OF DIRECTORS OR
6 OTHER ENTITY ESTABLISHED TO GOVERN THE COOPERATIVE HOUSING

9 affiliate of or a successor to the developer, who, for value, acquires a cooperative
10 interest as part of the initial sale of a cooperative interest which is used for residential
11 purposes.

12 [(l)] ~~(O)~~ (N) “Initial sale” means the first transfer of a cooperative interest to an
13 initial purchaser.

14 [(m)] ~~(P)~~ (O) “Member” means a person who owns a cooperative interest.

15 [(n)] ~~(Q)~~ (P) “Membership certificate” means:

16 (1) A document, including a stock certificate issued by a cooperative
17 housing corporation, evidencing ownership of a cooperative interest; or

18 (2) If there is no other document which satisfies paragraph (1) of this
19 subsection, a proprietary lease.

20 [(o)] ~~(R)~~ (Q) “Moving expenses” means costs incurred to:

21 (1) Hire contractors, labor, trucks, or equipment for the transportation
22 of personal property;

23 (2) Pack and unpack personal property;

24 (3) Disconnect and install personal property;

25 (4) Insure personal property to be moved; and

26 (5) Disconnect and reconnect utilities such as telephone service, gas,
27 water, and electricity.

29 (1) Is consistent with the residential character of the dwelling unit;

1 (2) Is subordinate to the use of the dwelling unit for residential
 2 purposes and requires no external modifications that detract from the residential
 3 appearance of the dwelling unit;

4 (3) Uses no equipment or process that creates noise, vibration, glare,
 5 fumes, odors, or electrical or electronic interference detectable by neighbors; and

6 (4) Does not involve use, storage, or disposal of any grouping or
 7 classification of materials that the United States Secretary of Transportation or the
 8 State or any local governing body designates as a hazardous material.

 10 cooperative housing corporation under which a member has an exclusive possessory

 14 the member, respectively.
