# Ethics Law – Financial Disclosure Statement by Elected Local Official of Municipal Corporation – Confidential Information

# FOR the purpose of altering certain financial disclosure provisions governing elected local officials of a municipal corporation; prohibiting the disclosure of certain information concerning certain relatives that is included in the financial disclosure statement filed by an elected local official of a municipal corporation; providing certain exceptions; and generally relating to the financial disclosure statement filed by an elected local official of a municipal corporation.

1 (II) AN ELECTED LOCAL OFFICIAL OF A MUNICIPAL 2 CORPORATION NEED NOT DISCLOSE INTERESTS IN REAL PROPERTY THAT IS 3 LOCATED OUTSIDE THE STATE UNLESS THE PROPERTY IS ACQUIRED FROM OR 4 IN CONJUNCTION WITH A PERSON THAT AT ANY TIME IN THE PAST **10** YEARS HAS 5 DONE BUSINESS WITH OR IS PRESENTLY DOING BUSINESS WITH THE MUNICIPAL 6 CORPORATION.

7 (c) (1) This subtitle does not compel the governing body of a county or 8 municipal corporation to require a local official to file a financial disclosure statement 9 except when the personal interest of the local official will present a potential conflict 10 with the public interest in connection with an anticipated public action of the local 11 official.

12 (2) The governing body of a county or municipal corporation shall 13 require a local official to file a financial disclosure statement at least annually to 14 report on gifts received by the local official.

15 (3) The financial disclosure provisions shall require that a statement 16 be filed:

(i) under paragraph (1) of this subsection sufficiently inadvance of the action to provide adequate disclosure to the public; and

4 [(d)] (E) Financial disclosure provisions applicable to a candidate shall be 5 consistent with the provisions applicable to an incumbent holding the office involved.
