A BILL ENTITLED

2 **Frederick County – Transition to Charter Government – Corrections to**
3 **References in the Annotated Code of Maryland**

4 FOR the purpose of correcting references to the government of Frederick County in the
5 Annotated Code of Maryland that will be rendered obsolete after the status of
6 the county is changed from a commission county to a charter county; altering
7 the manner in which certain authority may be exercised in the county; replacing
8 references to the County Manager with references to the Chief Administrative
9 Officer; repealing certain definitions; providing for an abnormal effective date;
10 and generally relating to the government of Frederick County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article – Corporations and Associations**

21 2–102.

22 (b) (3) The Department may not accept articles of incorporation from a
23 fire or rescue organization to be located in Frederick County for the purpose of
24 providing fire or rescue service in Frederick County unless the articles are
25 accompanied by a written resolution of the **GOVERNING BODY OF** Frederick County
26 [Board of Commissioners] indicating [the Board’s] approval of the proposed
27 incorporation. Incorporated municipalities in Frederick County with primary
28 responsibility for governmental funding for fire service shall within their jurisdiction
29 hold those powers assigned to the **GOVERNING BODY OF** Frederick County
30 [Commissioners] in this section.

31 **Article – Courts and Judicial Proceedings**

32 2–309.

33 (l) (1) The Sheriff of Frederick County shall receive a salary of \$100,000.
34 The Sheriff shall appoint deputies as necessary, at salaries of at least \$2,400, and jail
35 wardens as necessary, at salaries of at least \$1,320 each. The Sheriff also may appoint
36 additional temporary deputy sheriffs as the Sheriff considers necessary for the public
37 safety, with the approval of the [Board of County Commissioners] **GOVERNING BODY**

1 **OF FREDERICK COUNTY, BY ORDINANCE.** The [County Commissioners]
 2 **GOVERNING BODY, BY ORDINANCE,** shall allow reasonable compensation for the
 3 temporary additional deputy sheriffs and the temporary deputies may not serve longer
 4 than the occasion requires. The Sheriff may appoint a chief deputy who shall serve at
 5 the pleasure of the Sheriff.

6 (5) (ii) 2. Any additional funding required as a result of a
 7 negotiated collective bargaining agreement shall be [subject to approval by the Board
 8 of County Commissioners of] **IN THE** Frederick County **BUDGET.**

9 (iv) 2. The parties shall make every reasonable effort to
 10 conclude negotiations in a timely manner to allow for inclusion by the Office of the
 11 Sheriff of matters agreed upon in its budget request [to the Board of County
 12 Commissioners of Frederick County].

13 (v) 4. B. Additional funding, if any, required as a result
 14 of the agreement shall be subject to the approval of the [Board of County
 15 Commissioners] **GOVERNING BODY OF FREDERICK COUNTY.**

16 (6) (ii) 2. Any additional funding required as a result of a
 17 negotiated collective bargaining agreement shall be subject to approval by the [Board
 18 of County Commissioners] **GOVERNING BODY** of Frederick County.

19 (iv) 2. The parties shall make every reasonable effort to
 20 conclude negotiations in a timely manner to allow for inclusion by the Office of the
 21 Sheriff of matters agreed on in its budget request to the [Board of County
 22 Commissioners] **GOVERNING BODY** of Frederick County.

23 (v) 4. B. Additional funding, if any, required as a result
 24 of the agreement shall be subject to the approval of the [Board of County
 25 Commissioners] **GOVERNING BODY OF FREDERICK COUNTY.**

27 (a) (11) Frederick County — As set by the [County Commissioners]
 28 **COUNTY GOVERNMENT.**

31 (a) This section does not apply:

32 (2) in Frederick County if [the Board of County Commissioners of
 33 Frederick County adopts] regulations **ARE ADOPTED** under § 12–806 of the Local

1 Government Article providing for the registration of alarm system contractors and
2 alarm users, the issuance of civil citations, and penalties for a violation of a regulation;

4 [(a)] In this subtitle [the following words have the meanings indicated.

5 (b) “County commissioners” means the Board of County Commissioners of
6 Frederick County.

7 (c) “Gaming], “GAMING event” includes [a]:

8 (1) A bazaar;

9 (2) A carnival;

10 (3) A raffle;

11 (4) A tip jar; and

12 (5) A punchboard.

14 (d) The tip jar or punchboard shall be purchased from a distributor that:

15 (1) has an office in the State;

16 (2) is licensed by the county agency that issues gaming event permits;

18 (3) keeps the records that [the county commissioners require]

21 (a) A person authorized to conduct bingo under this subtitle shall obtain a
22 bingo permit from the county agency [designated by the county commissioners to

25 set by [the county commissioners] **FREDERICK COUNTY.**

26 (2) The county [commissioners] may require an applicant for a bingo

5 (d) (1) The terms of voting members are staggered as provided in
6 subsection (c) of this section.

7 (2) [The County Commissioners] **SUBJECT TO CONFIRMATION OF**
8 **THE COUNTY COUNCIL, THE COUNTY EXECUTIVE** shall appoint a qualified
9 individual to fill a vacancy on the county board for the remainder of the term and until
10 a successor is elected and qualifies.

13 As to contributions to the **COUNTY EXECUTIVE OF** Frederick County [Board of
14 County Commissioners] **OR TO A MEMBER OF THE FREDERICK COUNTY COUNCIL**

16 **FREDERICK COUNTY OR TO A MEMBER OF THE FREDERICK COUNTY COUNCIL,**

20 (a) In this part the following words have the meanings indicated.

21 (b) “Aggrieved party” means:

22 (1) a property owner whose property:

23 (i) adjoins, fronts, or is located near the subject property; or

24 (ii) is located within sight or sound of the subject property; or

25 (2) an individual located within the same subdivision as the subject
26 property or who lives up to three–quarters of a mile by road or otherwise one–half mile
27 away from the subject property.

28 (c) (1) “Applicant” means a person that is:

1 (i) a title owner or contract purchaser of land that is the subject
2 of an application;

3 (ii) a trustee who has an interest in land that is the subject of
4 an application, excluding trustees described in a mortgage or deed of trust; or

5 (iii) a holder of at least a 10% interest in land that is the subject
6 of an application.

7 (2) "Applicant" includes a person who is an officer or a director of a
8 corporation that actually holds title to the land, or is a contract purchaser of the land,
9 that is the subject of an application.

10 (3) "Applicant" does not include:

11 (i) a financial institution that has loaned money or extended
12 financing for the acquisition, development, or construction of or improvements on the
13 land that is the subject of an application;

14 (ii) a municipal corporation or public corporation;

15 (iii) a public authority;

16 (iv) an electric company or electric supplier applying for a
17 certificate of public convenience and necessity under § 7-207 or § 7-208 of the Public
18 Utilities Article; or

19 (v) a person who is hired or retained as an accountant, an
20 attorney, an architect, an engineer, a land use consultant, an economic consultant, a
21 real estate agent, a real estate broker, a traffic consultant, or a traffic engineer.

22 (d) "Application" means:

23 (1) an application for a zoning map amendment as part of a piecemeal
24 or floating zone rezoning proceeding;

25 (2) a formal application for a comprehensive map planning change or
26 zoning change during the county comprehensive land use plan update;

27 (3) an application for a map amendment to the county water and
28 sewerage plan;

29 (4) a request made under § 4-416 of the Local Government Article for
30 the [Board] GOVERNING BODY to approve the placement of annexed land in a zoning
31 classification that allows a land use that is substantially different from the use for the
32 land authorized in the zoning classification of the county applicable at the time of
33 annexation; or

1 (5) an application to create a district or an easement or any other
2 interest in real property as part of an agricultural land preservation program.

3 (e) ["Board" means the Board of County Commissioners for Frederick
4 County.

5 (f) "Board member" includes an individual elected or appointed to the Board
6 or a candidate who takes the oath of office for the Board.

7 (g) "Business entity" means:

8 (1) a corporation;

9 (2) a limited liability company;

10 (3) a partnership; or

11 (4) a sole proprietorship.

12 [(h) (F) "Candidate" means a candidate for [the Board] COUNTY
13 EXECUTIVE OR COUNTY COUNCIL who becomes [a member of the Board] AN
14 ELECTED OFFICIAL.

15 [(i) (G) "Contribution" means a payment or transfer of money or property
16 worth at least \$100, calculated cumulatively during the pendency of the application, to
17 a candidate or a treasurer or political committee of a candidate.

18 (H) "GOVERNING BODY" MEANS THE GOVERNING BODY OF FREDERICK
19 COUNTY.

20 [(j) (I) "Partnership" includes:

21 (1) a general partnership;

22 (2) a joint venture;

23 (3) a limited liability limited partnership;

24 (4) a limited liability partnership; or

25 (5) a limited partnership.

26 [(k) (J) "Party of record" means a person that participated in a proceeding
27 on an application before the [Board] GOVERNING BODY by appearing at a public
28 hearing or filing a statement in an official record.

1 **[(l)] (K)** “Pendency of the application” means the time between the
2 acceptance by the County Department of Planning and Zoning of a filing of an
3 application and the earlier of:

4 (1) 2 years after the acceptance of the application; or

5 (2) the expiration of 30 days after:

6 (i) the **[Board] GOVERNING BODY** has taken final action on
7 the application; or

8 (ii) the application is withdrawn.

9 **[(m)] (L)** “Political committee” means a committee specifically created to
10 promote the candidacy of a **[Board] member OF THE GOVERNING BODY** who is
11 running for an elective office.

12 **[(n)] (M)** “Treasurer” has the meaning stated in § 1–101 of the Election Law
13 Article.

14 5–858.

15 (a) An applicant may not make a contribution to a **[Board] member OF THE**
16 **GOVERNING BODY** during the pendency of the application.

17 (b) Except as provided in subsection (c) of this section, after an application
18 has been filed, a **[Board] member OF THE GOVERNING BODY** may not vote or
19 participate in any way in the proceedings on the application if the **[Board] member** or
20 the treasurer or political committee of the **[Board] member** received a contribution
21 from the applicant during the pendency of the application.

22 (c) A **[Board] member OF THE GOVERNING BODY** may participate in a
23 comprehensive zoning or rezoning proceeding.

24 5–859.

25 (a) This section does not apply to a communication between a **[Board]**
26 **member OF THE GOVERNING BODY** and an employee of the Frederick County
27 government whose duties involve giving aid or advice to a **[Board] member OF THE**
28 **GOVERNING BODY** concerning a pending application.

29 (b) A **[Board] member OF THE GOVERNING BODY** who communicates ex
30 parte with an individual concerning a pending application during the pendency of the
31 application shall file with the **[County Manager] CHIEF ADMINISTRATIVE OFFICER**

1 a separate disclosure for each communication within the later of 7 days after the
2 communication was made or received.

3 5–860.

4 At any time before final action on an application, a party of record may file with
5 the [County Manager] **CHIEF ADMINISTRATIVE OFFICER** an affidavit including
6 competent evidence of:

7 (1) a contribution by an applicant covered under § 5–858 of this
8 subtitle; or

9 (2) an ex parte communication covered under § 5–859 of this subtitle.

10 5–861.

11 (a) In the enforcement of this part, the [County Manager] **CHIEF**
12 **ADMINISTRATIVE OFFICER** shall be subject to the direction and control of the
13 Frederick County Ethics Commission and, unless otherwise specifically directed by the
14 County Ethics Commission, may only:

15 (1) receive filings;

16 (2) maintain records;

17 (3) report violations; and

18 (4) perform other ministerial duties necessary to administer this part.

19 (b) (1) The affidavits and disclosures required under this part shall be
20 filed in the appropriate case file of an application.

21 (2) The [County Manager] **CHIEF ADMINISTRATIVE OFFICER**, at
22 least twice each year, shall prepare a summary report compiling all affidavits and
23 disclosures that have been filed in the application case files.

24 (3) All summary reports compiled under paragraph (2) of this
25 subsection shall be available to members of the public on written request.

26 (4) All affidavits, disclosures, and accompanying documentation
27 required under this part shall be in the form required by the Frederick County Ethics
28 Commission.

29 5–862.

1 (a) (1) The Frederick County Ethics Commission or another aggrieved
2 party of record may assert as procedural error a violation of this part in an action for
3 judicial review of the application.

4 (2) If the court finds that a violation of this part occurred, the court
5 shall remand the case to the [Board] **GOVERNING BODY** for reconsideration.

6 (b) (1) A person that knowingly and willfully violates this part is guilty of
7 a misdemeanor and on conviction is subject to imprisonment not exceeding 6 months
8 or a fine not exceeding \$1,000 or both.

9 (2) If the person is a business entity and not an individual, each
10 member, officer, or partner of the business entity who knowingly authorized or
11 participated in the violation is guilty of a misdemeanor and on conviction is subject to
12 imprisonment not exceeding 6 months or a fine not exceeding \$1,000 or both.

13 (3) An action taken in reliance on an opinion of the State Ethics
14 Commission or the Frederick County Ethics Commission may not be considered a
15 knowing and willful violation.

16 (c) (1) A person that is subject to this part shall preserve all books,
17 papers, and other documents necessary to complete and substantiate any reports,
18 statements, or records required to be made under this part for 3 years from the date of
19 filing the application.

20 (2) The documents shall be available for inspection on request.

21 **Article – Health – General**

22 21–304.

23 (e) (1) The [County Commissioners for] **GOVERNING BODY OF** Frederick
24 County may adopt [a law,] an ordinance[, a rule, or a regulation] to allow a restaurant
25 with an outdoor dining area to allow a patron’s dog to accompany the patron in the
26 outdoor dining area.

27 **Article – Land Use**

28 9–1002.

29 Notwithstanding any other provision of this division, the [board of county
30 commissioners] **GOVERNING BODY OF FREDERICK COUNTY** may overrule an action
31 of the county planning commission under Title 3, Subtitle 2 or 3 of this article [by a
32 majority vote of the membership of the board of county commissioners].

33 **Article – Local Government**

1 1-1007.

2 (a) (1) (i) Except as provided in subsection (d)(1) of this section, a
3 board consists of 10 members.

4 (ii) The county commissioners [or], **THE** county council of the
5 county, **OR, SUBJECT TO THE CONFIRMATION OF THE FREDERICK COUNTY**
6 **COUNCIL, THE COUNTY EXECUTIVE OF FREDERICK COUNTY** shall appoint the
7 initial members of the board for the following terms:

- 8 1. three members for 3 years;
9 2. three members for 2 years; and
10 3. three members for 1 year.

11 (iii) The county commissioners [or], **THE** county council, **OR,**
12 **SUBJECT TO THE CONFIRMATION OF THE FREDERICK COUNTY COUNCIL, THE**
13 **COUNTY EXECUTIVE OF FREDERICK COUNTY** shall appoint one of its members to
14 be an ex officio member of the board.

15 (c) [The County Commissioners] **SUBJECT TO THE CONFIRMATION OF**
16 **THE FREDERICK COUNTY COUNCIL, THE CHIEF EXECUTIVE** of Frederick County
17 shall appoint a successor member for:

- 18 (1) a term of 3 years if a term expires; or
19 (2) the rest of the term if a term is vacated.

21 In addition to the authority provided in this part, the [County Commissioners]
22 **GOVERNING BODY** of Frederick County may establish, maintain, and operate a
23 nursing home or other facility or service for the care and treatment of aged,
24 convalescent, and chronically ill individuals in Frederick County.

26 (c) (1) In addition to any benefit paid in accordance with subsection (a) of
27 this section, the [County Commissioners] **GOVERNING BODY** of Frederick County
28 may pay an additional \$8 per month to any retiree described in subsection (a)(1) of
29 this section.

1 (2) The [County Commissioners] **GOVERNING BODY** shall impose a
2 tax in an amount sufficient to pay for the additional benefit described in paragraph (1)
3 of this subsection.

4 12-301.

5 [(d) (1) (i) In Frederick County, subsection (c) of this section applies
6 only to a contract for services or the purchase of supplies if the contract exceeds
7 \$30,000.

8 (ii) In Frederick County, subsection (c) of this section does not
9 apply to a contract solely for architectural, engineering, or consulting services.

10 (2) The County Commissioners of Frederick County may award a
11 contract for architectural, engineering, or consulting services with a value that exceeds
12 \$30,000:

13 (i) on a competitive basis that consists of competitive sealed
14 bids or competitive negotiation that includes the submission of written technical and
15 price proposals from two or more offerors and a written evaluation of the proposals in
16 accordance with evaluation criteria; or

17 (ii) based on an evaluation of the technical proposals and
18 qualifications of at least two persons, with the contract set at a rate of compensation
19 that is fair, competitive, and reasonable.]

20 [(e)](D) In Somerset County, subsection (c) of this section does not apply to
21 a contract solely for design or consultation services.

22 12-408.

23 (a) (1) [The County Commissioners of] Frederick County may:

24 (i) purchase or lease personal property under a multiyear
25 contract that requires the county [commissioners] to make installment or rental
26 payments during 2 or more fiscal years;

27 (ii) pay interest as part of any installment or rental payments in
28 accordance with the terms of the contract; and

29 (iii) pledge and assign the personal property purchased or leased
30 to secure the obligation.

31 (2) (i) The county [commissioners] may enter into a contract under
32 paragraph (1) of this subsection only if:

1 1. the county [commissioners have] **HAS** appropriated
2 money sufficient to pay the amount due under the contract during the first fiscal year
3 in which the contract is effective;

4 2. subject to subparagraph (ii) of this paragraph, the
5 contract authorizes the county [commissioners] to terminate the contract if money
6 sufficient to pay the amount due under the contract for any fiscal year is not
7 appropriated;

8 3. the contract provides that, except if the county
9 [commissioners default] **DEFAULTS** in payment under the contract, an obligation for
10 payment under the contract is limited to money appropriated for contract payment for
11 that fiscal year; and

12 4. the contract provides that, if the county
13 [commissioners default] **DEFAULTS** in payment under the contract, the obligation for
14 payment is limited to:

15 A. money appropriated for contract payments for that
16 fiscal year;

17 B. any money realized from the personal property
18 purchased or leased under the contract; and

19 C. any other money legally available for contract
20 payment.

21 (ii) The contract may provide that a contract termination is
22 ineffective if the county [commissioners purchase or lease] **PURCHASES OR LEASES**
23 personal property similar or functionally related to the property purchased or leased
24 under the contract within a specified period of time.

25 (b) [The County Commissioners of] Frederick County may sell to a
26 government unit located in the county or to the Frederick Memorial Hospital, Inc.,
27 surplus school board real property:

28 (1) without advertising the property for sale; and

29 (2) after obtaining three independent appraisals.

30 (c) [The County Commissioners of] Frederick County may sell surplus
31 county real property at a public or private sale if, subject to county procedures, the
32 [county commissioners hold] **GOVERNING BODY OF FREDERICK COUNTY HOLDS** a
33 hearing on the sale and [provide] **PROVIDES** adequate notice of the hearing.

34 (d) (1) [The County Commissioners of] Frederick County may:

1 (i) accept a donation of real property that is not needed for a
2 public purpose; and

3 (ii) sell the property by public or private sale for consideration
4 that the county [commissioners determine] **DETERMINES** to be adequate.

5 (2) The county [commissioners] shall use all proceeds from the sale of
6 real property under this subsection in accordance with the county budget or a
7 resolution adopted by the [county commissioners] **GOVERNING BODY**.

8 (3) A sales agreement entered into under this subsection is not
9 effective until:

10 (i) a copy of the agreement is filed with the clerk of the court;
11 and

12 (ii) a summary of the agreement is published in at least one
13 newspaper of general circulation in the county.

14 (e) [The County Commissioners of]Frederick County may sell an abandoned
15 right-of-way in the county by public or private sale, after advertising the property for
16 sale for at least 20 days.

17 12-522.

18 If any road in Frederick County has not been maintained [by the County
19 Commissioners of Frederick County] for a period of 20 years before July 1, 1973, it
20 shall be conclusively presumed that the road was closed in accordance with this
21 subtitle.

22 12-806.

23 (c) (1) The [county commissioners] **GOVERNING BODY OF A COUNTY**
24 may adopt regulations to:

25 (i) register alarm system contractors operating in the county;

26 (ii) register alarm users in the county;

27 (iii) provide penalties for failure to register as an alarm system
28 contractor or alarm user;

29 (iv) provide civil citations and penalties for false alarms,
30 notwithstanding Title 9, Subtitle 6, Part II of the Criminal Law Article;

1 (v) provide exemptions from the issuance of civil citations and
2 penalties for false alarms;

3 (vi) authorize the designated county enforcement agency to
4 maintain a record of the alarm system contractor, monitoring service, and
5 manufacturer of each security system in operation in the county; and

6 (vii) authorize the designated county enforcement agency, if it
7 finds a pattern of false alarms attributed to a particular manufacturer's model or to
8 installation by a particular alarm system contractor, to inform:

9 1. the manufacturer of the model or the alarm system
10 contractor that installed the alarm system; and

11 2. the appropriate State or national licensing agency or
12 the certification standards entity.

13 13–121.

14 (a) (1) The [County Commissioners] **GOVERNING BODY** of Frederick
15 County, by ordinance, may provide for a comprehensive system for the regulation of
16 domestic animals and wild animals kept in captivity.

17 (2) The ordinance may provide for:

18 (i) the licensing and control of domestic animals and wild
19 animals kept in captivity;

20 (ii) seizing and disposing of unlicensed or dangerous dogs;

21 (iii) the regulation of persons who own or keep any vicious
22 animal or an animal that disturbs the peace of a neighborhood; and

23 (iv) reasonable penalties for a violation of an ordinance not
24 exceeding imprisonment for 30 days or a fine of \$500 or both.

25 (3) The [county commissioners] **GOVERNING BODY**:

- 4 (iv) seizing and disposing of any dogs found running at large in

8 subsection, the proposed [rule, regulation, or resolution] ordinance shall be advertised

10 weeks, to provide any person an opportunity to be heard.

11 (3) The [rules, regulations, or resolutions] ordinance shall include
12 standards and operate uniformly.

13 (4) Subject to paragraph (5) of this subsection, the [county
14 commissioners] **GOVERNING BODY** may delegate, by written contract, the
15 enforcement of the [rules, regulations, or resolutions] ordinance.

16 (5) (i) The [county commissioners] **GOVERNING BODY** shall
17 reserve the right to cancel a written contract executed in accordance with paragraph
18 (4) of this subsection.

19 (ii) A cancellation under this paragraph:

20 1. may be without notice or recourse, if the cancellation
21 is for cause; or

22 2. requires notice at least 30 days before cancellation, if
23 the cancellation is without cause.

24 (c) The powers granted to the [County Commissioners] **GOVERNING BODY**
25 of Frederick County to regulate dogs are also granted for the regulation of cats.

26 (d) (1) In Frederick County, on or before July 1 of each year, a person
27 owning or keeping a dog shall apply to the county tax collector for a license for the dog
28 if the dog is at least 6 months old.

29 (2) At the time of application, the applicant shall pay the fee for a dog
30 or kennel license set by the [County Commissioners of Frederick County] **COUNTY**.

1 (3) Except as provided in § 13–108 of this subtitle, the licenses and
2 fees required under this section are the only licenses and fees required for owning or
3 keeping a dog.

4 (4) The county [commissioners] shall prepare and supply the form for
5 a license issued under this subsection.

6 (5) A dog license shall contain the date of issuance, a serial number,
7 and a description of the dog licensed.

8 (6) A license expires on July 1 of the year after issuance.

9 (e) (1) In Frederick County, the county tax collector shall issue a tag with
10 each dog license to a person owning or keeping a dog when the person pays the license
11 fee for the dog.

12 (2) The [County Commissioners of Frederick County] COUNTY shall
13 prepare and supply tags to the county tax collector each year.

14 (3) The tags shall be:

15 (i) composed of metal;

16 (ii) imprinted with a serial number corresponding to the
17 number on the license issued to the owner under subsection (d) of this section;

18 (iii) imprinted with the calendar year for which the tag is issued;

19 (iv) 1 inch or less in length; and

20 (v) equipped with a substantial metal fastener.

21 (4) The county [commissioners] shall change the general shape of the
22 tags each year.

23 (5) Tags supplied to owners of kennels shall contain the word
24 “kennel”.

25 (6) The person owning or keeping a dog shall attach the tag to a
26 substantial collar and keep the collar and tag on the dog for which the license was
27 issued at all times, except when the dog is:

29 (ii) hunting under the charge of an attendant.

30 (7) The county tax collector shall replace a lost tag on:

1 (i) application by the person to whom the original license was
2 issued;

3 (ii) the production of the license; and

4 (iii) payment of a fee of 25 cents.

5 (f) (1) [The County Commissioners of] Frederick County may contract
6 with an animal welfare society, a humane society, or any other qualified person to:

7 (i) establish an animal shelter; and

8 (ii) seize, dispose of, and euthanize stray, injured, or sick dogs.

9 (2) Notwithstanding § 13–105(d) of this subtitle, the county
10 [commissioners] may use proceeds from dog license fees to:

11 (i) establish an animal shelter; and

12 (ii) collect and euthanize stray, injured, or sick dogs.

13 (g) (1) In Frederick County, the owner or custodian of a female dog that is
14 in heat:

15 (i) may not knowingly allow the dog to run at large; and

16 (ii) shall confine the dog.

17 (2) A person who violates this subsection is guilty of a misdemeanor
18 and on conviction is subject to a fine not exceeding \$25.

20 The [county commissioners] **GOVERNING BODY** of a county may license and
21 regulate transient vendors in the county.

22 13–306.

23 At least 30 days before the date of intended sale in a county, a transient vendor
24 shall submit to the [county commissioners] **GOVERNING BODY** of the county a
25 verified, written application that contains:

26 (1) the name and address of the applicant and the owner of the goods
27 to be sold or exhibited for sale;

1 (2) the name and address of the employer of the applicant or persons
2 with whom the applicant is associated and the length of the employment or
3 association;

4 (3) a description of the nature and place of the applicant's employment
5 during the preceding 12 months;

6 (4) (i) an estimate of the length of time that and exact location
7 where the applicant will pursue the activities regulated under this part; and

8 (ii) if a fixed site is occupied, the address of the property owner
9 of the site;

10 (5) the names and addresses of at least three individuals who:

11 (i) have known the applicant for at least 1 year; and

12 (ii) will verify the facts contained in the application;

13 (6) the applicant's Maryland sales and use tax number;

14 (7) (i) the address of any permanent place of business of the
15 applicant in the State; or

16 (ii) a copy of the certificate from the State Department of
17 Assessments and Taxation stating that the applicant has qualified to do business in
18 the State and the name and address of the applicant's agent;

19 (8) proof that the applicant:

20 (i) is qualified to do business in the State and the county; and

21 (ii) has obtained all necessary permits and licenses from the
22 State and the county for the operation of the business;

23 (9) a description of the nature of the business and the goods intended
24 for sale or the catalog from which goods can be ordered;

25 (10) a description and motor vehicle registration plate number of any
26 vehicle used in connection with the applicant's activities;

27 (11) a statement as to whether the applicant has ever been convicted of
28 a felony or a misdemeanor and, if so, a statement as to:

29 (i) the nature of the offense;

30 (ii) when and where the applicant was convicted; and

1 (iii) the penalty imposed;

2 (12) a description of the place where the goods are manufactured, the
3 location of the goods at the time of the filing of the application, and the proposed
4 method of delivery of the goods; and

5 (13) any additional information that the [county commissioners
6 require] **GOVERNING BODY REQUIRES.**

7 13–307.

8 (a) (1) An applicant for a transient vendor license shall execute and file a
9 bond with the [county commissioners] **GOVERNING BODY** of the county in the amount
10 of \$10,000.

11 (2) The bond shall be issued by a surety:

12 (i) authorized to do business in the State; and

13 (ii) approved by the [county commissioners] **GOVERNING**
14 **BODY.**

15 (b) (1) The bond shall be payable to the extent of any taxes, fees, or fines.

16 (2) The surety shall indemnify a purchaser who suffers a loss because

24 (2) The bond shall provide that a purchaser at a sale may maintain an
25 action for claims arising from the sale against a licensee or the surety.

26 (d) The bond shall continue in effect for at least 1 year after the termination
27 of the transient vendor license expires and until:

28 (1) all actions are concluded and judgments have been satisfied; or

1 (2) the amount of the bond has been exhausted by payments on
2 judgments.

3 (e) The bond shall be in addition to any deposit, license fee, permit fee, or
4 other requirement under county law.

5 13-308.

6 (a) (1) The [county commissioners] **GOVERNING BODY** of a county shall
7 verify the statements made by the applicant in the application for the transient vendor
8 license.

9 (2) (i) If the application contains a false statement, the [county
10 commissioners] **GOVERNING BODY** may deny the license.

11 (ii) If the license is denied, the [county commissioners]
12 **GOVERNING BODY** shall refund the license fee, less administrative costs.

13 (b) (1) The [county commissioners] **GOVERNING BODY** of a county shall
14 issue a transient vendor license within 20 days after the application is filed if:

15 (i) the [county commissioners approve] **GOVERNING BODY**
16 **APPROVES** the application and surety bond; and

17 (ii) the license fee is paid.

18 (2) The license shall:

19 (i) be effective for the duration and term applied for in the
20 application not to exceed a period of 1 year; and

23 The [County Commissioners] **GOVERNING BODY** of Frederick County may
24 enact [a local law or adopt regulations] **AN ORDINANCE** to control the increase of rent
25 in the county.

27 The [County Commissioners] **GOVERNING BODY** of Frederick County shall
28 establish and maintain a bond rating enhancement reserve.

29 20-419.

1 (a) Frederick County shall distribute the hotel rental tax revenue as follows:

2 (1) a reasonable sum for hotel rental tax administrative costs to the
3 general fund of the county; and

4 (2) the remaining balance to the Tourism Council of Frederick County,
5 Inc., with a portion of the balance designated by the [county commissioners]
6 **GOVERNING BODY OF FREDERICK COUNTY** to be used for a visitor center.
