A BILL ENTITLED

1 AN ACT concerning

2 **Anne Arundel County – Alcoholic Beverages – Tasting Licenses**

3 FOR the purpose of creating in Anne Arundel County a BWLT beer, wine, and liquor
4 (on–premises) tasting license; specifying that the BWLT license may be issued
5 to certain persons; creating a license fee schedule for a BWLT license and
6 altering the fee schedule for a BWT beer and wine (on–premises) tasting license;
7 specifying certain limitations on the amount of alcoholic beverages that may be
8 offered for on–premises consumption; and generally relating to alcoholic
9 beverages licenses in Anne Arundel County.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article 2B – Alcoholic Beverages**

18 8–402.

19 (a) This section applies only in Anne Arundel County.

20 (b) In this section, “Board” means the Anne Arundel County Board of License
21 Commissioners.

22 (c) There is a Class **BWLT BEER, WINE, AND LIQUOR**
23 **(ON–PREMISES) TASTING LICENSE, A BWT beer and wine (on–premises) tasting**

1 license, a WS wine sampling (on-premises) license, and a Class WT wine tasting
2 (on-premises) license.

3 (d) (1) **(I) A CLASS BWLT LICENSE MAY BE ISSUED ONLY TO A**
4 **HOLDER OF A CLASS BWL BEER, WINE AND LIQUOR (ON-PREMISES) LICENSE.**

5 **(II)** A Class BWT license may only be issued to a holder of a
6 Class BWL beer, wine and liquor (on-premises) license or a Class BW beer and wine
7 (on-sale) license.

8 (2) The annual fee for a Class BWT license is[:

9 (i) \$50 for a holder of a Class BWL license; and

10 (ii) \$50 for a holder of a Class BW license] **\$150.**

11 **(3) THE ANNUAL FEE FOR A CLASS BWLT LICENSE IS \$500.**

12 **[(3)] (4)** The annual fee for a Class **BWLT OR** BWT license is in
13 addition to the Class BWL or BW annual fee.

14 **(5) A CLASS BWLT LICENSE AUTHORIZES A HOLDER TO**
15 **PERMIT THE ON-PREMISES CONSUMPTION OF THE FOLLOWING ALCOHOLIC**
16 **BEVERAGES FOR TASTING OR SAMPLING PURPOSES ONLY:**

17 **(I) LIQUOR TO BE SERVED IN A QUANTITY OF NOT MORE**
18 **THAN ONE-HALF OUNCE FROM EACH OF ANY OF FIVE BRANDS TO ANY ONE**
19 **PERSON PER DAY;**

20 **(II) LIGHT WINE TO BE SERVED IN A QUANTITY OF NOT**
21 **MORE THAN 1 OUNCE FROM EACH GIVEN BRAND TO ANY ONE PERSON; AND**

22 **(III) BEER TO BE SERVED IN A QUANTITY OF NOT MORE**
23 **THAN 3 OUNCES TO ANY ONE PERSON.**

24 **[(4)] (6)** The Class BWT license authorizes a holder to permit the
25 on-premises consumption of the following alcoholic beverages for tasting or sampling
26 purposes only:

27 (i) Light wine to be served in a quantity of not more than 1
28 ounce from each given brand to any one person; and

29 (ii) Beer to be served in a quantity of not more than 3 ounces to
30 any one person.

1 (e) (1) The Board may issue a WS (wine sampling) license to bona fide
2 nonprofit organizations.

3 (2) The WS license authorizes the consumption of wine for tasting or
4 sampling purposes:

5 (i) On Class B beer and wine or beer, wine and liquor licensed
6 premises with the consent of the licensee; or

7 (ii) On premises without a permanent alcoholic beverages
8 license.

9 (3) The licensee may not serve more than 2 ounces from each brand to
10 any 1 person.

11 (4) The bona fide nonprofit organization:

12 (i) Shall apply for a WS license at least 15 days prior to the day
13 of issuance; and

14 (ii) May not be issued more than 12 WS licenses in any given
15 license year.

16 (5) The daily license fee is \$15.

17 (6) The WS licensee may bring wine onto Class B licensed premises for
18 sampling or tasting purposes only.

19 (f) (1) A Class WT wine tasting (on-premises) license may only be issued
20 to a holder of a Class BWL license or a holder of a Class BW license.

21 (2) A Class WT wine tasting (on-premises) license authorizes a holder
22 to permit the on-premises consumption for tasting or sampling purposes only of light
23 wine to be served in a quantity of not more than 1 ounce from each given brand to any
24 one person.

25 (3) The annual license fee is:

26 (i) \$150 for a holder of a Class BWL license; and

27 (ii) \$50 for a holder of a Class BW license.

28 (g) The provisions of this section are not restricted by:

29 (1) The provisions in subsection (b) of § 12-107 of this article; and

1 (2) The provisions of law under § 9–102 of this article prohibiting the
2 issuance of 2 licenses for the same premises.

3 (h) In the City of Annapolis, the Mayor and City Council may approve the
4 issuance of a BWT license or a WS license. The fees for the licenses shall be set by the
5 Mayor and City Council.

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
7 July 1, 2014.
