A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2011 – Prince George’s County**
3 **– Capitol Heights Seat Pleasant Boys and Girls Club Initiative**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2011
5 to add additional grantees to certain grants; expanding the authorized uses of
6 certain grants; extending the deadline for certain grantees to provide evidence
7 of certain matching funds; and generally relating to amending the Maryland
8 Consolidated Capital Bond Loan of 2011.

9 BY repealing and reenacting, with amendments,
10 Chapter 396 of the Acts of the General Assembly of 2011, as amended by
11 Chapter 430 of the Acts of the General Assembly of 2013
12 Section 1(3) Item ZA02(BJ) and Item ZA03(AW)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
