## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2010 – Baltimore City –**  
3 **Franklin Entrepreneurial and Apprenticeship Center**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2010  
5 to alter the type of matching fund that may be provided by the Board of  
6 Directors of the Druid Heights Community Development Corporation for certain  
7 grants; extending the deadline for a certain grantee to present evidence of  
8 certain matching funds for certain grants; providing that certain grants may not  
9 terminate before a certain date; and generally relating to amending the  
10 Maryland Consolidated Capital Bond Loan of 2010.

11 BY repealing and reenacting, with amendments,  
12 Chapter 483 of the Acts of the General Assembly of 2010, as amended by  
13 Chapter 639 of the Acts of the General Assembly of 2012
