Business Occupations – Real Estate Appraisers – Criminal History Records Checks

- 4FOR the purpose of requiring applicants for a license to provide real estate appraisal $\mathbf{5}$ services and applicants for a certificate to provide certified real estate appraisal 6 services to apply in a certain manner for a national and State criminal history 7 records check, submit certain fingerprints, and pay certain fees for the records 8 checks; requiring the Criminal Justice Information System Central Repository 9 of the Department of Public Safety and Correctional Services to provide the 10 records and a certain receipt to the State Commission of Real Estate 11 Appraisers, Appraisal Management Companies, and Home Inspectors; providing that certain information obtained by the Commission is confidential; 12requiring the Commission to deny a real estate appraisal license or certificate to 13 14an applicant under certain circumstances; defining a certain term; providing for 15a delayed effective date; and generally relating to criminal history records 16 checks for real estate appraisers.
