# 2 Business Occupations – Real Estate Appraisers – Criminal History Records 3 Checks

FOR the purpose of requiring applicants for a license to provide real estate appraisal 4 5 services and applicants for a certificate to provide certified real estate appraisal 6 services to apply in a certain manner for a national and State criminal history 7 records check, submit certain fingerprints, and pay certain fees for the records 8 checks; requiring the Criminal Justice Information System Central Repository 9 of the Department of Public Safety and Correctional Services to provide the 10 records and a certain receipt to the State Commission of Real Estate Appraisers, Appraisal Management Companies, and Home Inspectors; 11 providing that certain information obtained by the Commission is confidential; 12 13 requiring the Commission to deny a real estate appraisal license or certificate to an applicant under certain circumstances; defining a certain term; providing for 14 15 a delayed effective date; and generally relating to criminal history records 16 checks for real estate appraisers.
