FISCAL AND POLICY NOTE

House Bill 5

(Chair, Economic Matters Committee)(By Request - Departmental - Labor, Licensing and Regulation)

Economic Matters

State Board of Plumbing - Continuing Professional Competency - Master Plumbers and Master Natural Gas Fitters

This departmental bill requires the State Board of Plumbing to establish, by regulation, continuing professional competency requirements for licensed master plumbers and licensed master natural gas fitters. Licensees must complete eight educational hours as a condition of each license renewal beyond the first. The requirement is phased in for specified licensees whose license expires before October 1, 2017. Prior to proposing regulations, the board must convene a workgroup with interested stakeholders to act in an advisory capacity in the development of provisions regarding subject matter, approved providers, and other issues related to continuing professional competency.

Fiscal Summary

State Effect: None. The bill's requirements can be handled with existing budgeted resources.

Local Effect: None.

Small Business Effect: The Department of Labor, Licensing, and Regulation (DLLR) has determined that this bill has minimal or no impact on small business (attached). The Department of Legislative Services concurs with this assessment.

Analysis

Current Law: The State Board of Plumbing is housed within DLLR's Division of Occupational and Professional Licensing. The board has three statutorily established purposes: (1) to protect the integrity of the potable water supply; (2) to provide for the

efficient and safe discharge of storm drainage and sanitary drainage; and (3) to ensure that qualified individuals carry out the board's charge.

Under State law, the board regulates the plumbing industry throughout most of Maryland, but it lacks jurisdiction in Baltimore County as well as in areas of Montgomery and Prince George's counties under the jurisdiction of the Washington Suburban Sanitary Commission. The licenses issued by the board are not valid in these jurisdictions; however, Baltimore County does require applicants for their journey examination to hold a current State apprentice license.

To provide plumbing services or natural gas fitting services throughout most of the State, a person must be licensed by the board. The board issues three different levels of license: master; journey/journeyman; and apprentice. Plumbing licenses are typically held in conjunction with the equivalent natural gas fitters license. Licenses are valid for two years and are issued on a staggered basis.

Background: Other boards within DLLR's Division of Occupational and Professional Licensing recently required to establish programs of continuing professional competency include those which regulate professional engineers (2010), home inspectors (2011), architects (2012), and landscape architects (2013). Continuing education requirements for master electricians were also required beginning in 2011. Prior Introductions: SB 77 of 2013, a similar bill, passed the Senate but received an unfavorable report from the House Economic Matters Committee.
