Maryland Health Care Commission - Powers - Authority to Award Funds and Make Agreements With Grantees and Payees

This departmental bill authorizes the Maryland Health Care Commission (MHCC) to award grants and make agreements with grantees or payees. In awarding funds, MHCC must (1) use a competitive process that affords interested persons an opportunity to submit a proposal for funding and (2) evaluate proposals using a panel of internal and external evaluators. MHCC must provide information on its website that is easily accessible to the public about funds to be awarded and how to submit a proposal. MHCC must submit an annual report to the General Assembly listing all funds awarded.

Fiscal Summary

State Effect: Authorizing MHCC to award grants and make agreements with payees is procedural in nature and does not directly affect governmental finances. MHCC currently receives federal and other funds but cannot directly distribute them. MHCC can implement the bill's requirements regarding competitive bidding, evaluating proposals, and provision of information to the public using existing budgeted resources as these requirements codify current practice.

Local Effect: None.

Small Business Effect: The Department of Health and Mental Hygiene (DHMH) has determined that this bill has minimal or no impact on small business (attached). The Department of Legislative Services concurs with this assessment. (The attached assessment does not reflect amendments to the bill.)

Analysis

Current Law: MHCC is authorized to apply for and accept any funds, property, or services from any person or government agency and make agreements with a grantor or payor of funds, property, or services, including an agreement to make any study, plan, demonstration, or project.

Background: In recent years, MHCC has received some significant grants, including \$10.9 million from the U.S. Department of Health and Human Services for health information technology and \$2.8 million from the federal Centers for Medicare and Medicaid Services' Center for Consumer Information and Insurance Oversight. While MHCC may receive such funding, it is not authorized to award those funds as grants to other State organizations. Instead, MHCC must either use the procurement process or transfer funds to DHMH to make the award on behalf of MHCC. According to MHCC, these procedures are time consuming and make it difficult for MHCC to manage the grantee; thus, the bill is intended to streamline the award process and allow for more seamless grant oversight.
