Senate Bill 639 Judicial Proceedings (Anne Arundel County Senators)

Rules and Executive Nominations

Anne Arundel County - State's Attorney - Annual Salary and Compensation

This bill repeals the existing statutory provisions that govern the method by which the salary for the Anne Arundel County State's Attorney is set. Instead, the bill establishes that the salary is (1) \$168,000 for calendar 2015; (2) \$171,000 for calendar 2016; (3) \$174,000 for calendar 2017; and (4) \$177,000 for calendar 2018 and subsequent years. The bill also requires that the State's Attorney be provided with a vehicle to use for official duties.

Fiscal Summary

State Effect: None.

Local Effect: Salary expenditures decrease by approximately \$1,300 in FY 2015; the savings increase over time. By FY 2019, salary expenditures decrease by approximately \$12,100. Revenues are not affected.

Small Business Effect: None.

Analysis

Current Law/Background: Chapter 168 of 2000 established that for calendar 2003, the salary of the State's Attorney in Anne Arundel County was to be equal to the salary of a circuit court judge as of December 31, 2002. In each calendar year thereafter, the salary increases by 3%. Accordingly, the calendar 2014 salary for the Anne Arundel State's Attorney is \$165,551, which reflects a 3% increase over the calendar 2013 salary of \$160,729. **Exhibit 1** shows the salary for the State's Attorney in each county based on fiscal 2014 data (where available), as provided by the Maryland Association of Counties.

Salaries for the two deputy State's Attorneys are subject to the approval of the county and may not exceed 90% of the State's Attorney's salary. Salaries for assistant State's Attorneys are subject to approval by the county and may not exceed 80% of the State's Attorney's salary. Subject to approval by the administrative judge of the circuit court, the

State's Attorney may appoint a temporary assistant State's Attorney for a particular case or series of cases. The State's Attorney may set compensation for the temporary assistant State's Attorney, subject to the approval of the county.

Senate Joint Resolution 3 of 2012 established the following salaries for circuit court judges: (1) \$144,908 in fiscal 2014; (2) 149,600 in fiscal 2015; and (3) \$154,433 in fiscal 2016. Until the salary increases established in 2012, judicial salaries had not increased since fiscal 2009.

Article III, § 35 of the Maryland Constitution prohibits the salary or compensation of any public officer from being increased or diminished during the individual's term of office, except those whose full term is fixed by law in excess of four years.

Local Fiscal Effect: Salary expenditures decrease by \$1,259 in fiscal 2015, by \$3,576 in fiscal 2016, by \$5,769 in fiscal 2017, by \$8,117 in fiscal 2018, and by \$12,125 in fiscal 2109.

County expenditures may increase minimally beginning in fiscal 2015 to provide the State's Attorney with a vehicle to use for official duties. These estimates reflect the elimination of the statutory 3% salary increase, but do not include any minimal additional impact on fringe benefits. **Exhibit 2** illustrates the difference in the salary of the State's Attorney (based on calendar year) as a result of the bill's establishment of specified salaries for calendar 2015 and beyond.
