## AMENDMENT NO. 1

On page 1, in line 6, after "for" insert "applicants for"; in line 7, after "waive" insert "certain examination requirements"; and in line 9, strike "examination requirements" and substitute "examinations".

## AMENDMENT NO. 2

On page 2, in line 3, strike "THAT INCLUDES" and substitute "FROM A COLLEGE OR UNIVERSITY THAT IS ACCREDITED BY, OR IS A CONSTITUENT UNIT OF AN INSTITUTION ACCREDITED BY, THE MIDDLE STATES ASSOCIATION OF COLLEGES AND UNIVERSITIES OR THE EQUIVALENT REGIONAL ACCREDITING ASSOCIATION OF OTHER REGIONAL AREAS AND POSSESSES, BEGINNING ON OCTOBER 1, 2023,"; in line 7, after "(3)" insert:

## "(I) ON OR BEFORE SEPTEMBER 30, 2017,";

in the same line, strike the second set of brackets; in the same line, strike "4"; in line 8, after the first bracket, insert "OF"; in line 10, strike "and" and substitute "OR"; and after line 10, insert:

"(II) BEGINNING ON OCTOBER 1, 2017, HAS AT LEAST 4
YEARS OF EXPERIENCE IN LAND SURVEYING THAT IS SATISFACTORY TO THE
BOARD AND THAT INDICATES TO THE BOARD THAT THE APPLICANT MAY BE
COMPETENT TO PRACTICE LAND SURVEYING; AND".

## AMENDMENT NO. 3

On page 2, in line 23, strike "LAND"; in line 25, after "(4)" insert:
