in lines 11 and 17, strike "(1)" and "(2)", respectively, and substitute "<u>(I)</u>" and "<u>(II)</u>", respectively; in lines 13 and 18, in each instance, strike "(i)" and substitute "<u>1</u>."; in lines 15 and 22, in each instance, strike "(ii)" and substitute "<u>2</u>."; in lines 15 and 20, in each instance, strike the brackets; in lines 15 and 16 and 20 and 21, in each instance, strike "THE STATE MINIMUM WAGE RATE SET UNDER SUBSECTION (C) OF THIS SECTION"; in lines 19 and 20, strike "1." and "2.", respectively, and substitute "<u>A.</u>" and "**B.**", respectively; after line 24, insert:

"(C) (1) THIS SUBSECTION APPLIES TO AN EMPLOYER THAT EMPLOYS MORE THAN 50 EMPLOYEES.
