SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 11 12That the Laws of Maryland read as follows:

16 give, transfer, promise, or offer anything of value for the purpose of (1)inducing another person to sign or not sign any petition; 17

18 (2)request, receive, or agree to receive, anything of value as an inducement to sign or not to sign any petition; 19

20misrepresent any fact for the purpose of inducing another person to sign (3)21or not to sign any petition;

(4) sign the name of any other person to a petition;
