In this section, "Board" means the Board of License Commissioners, 8 (3)9 unless otherwise noted. 10 (f) (1) This subsection applies only in Calvert County. 11 (2) The Board may appoint: A clerk and an attorney at a salary to be set by the County 12 (i) 13 Commissioners; and 14 With the approval of the County Commissioners, full-time or part-time alcoholic beverages inspectors whose salary shall be set by the County 15 16 Commissioners on an annual or per diem basis, and who shall be paid reasonable expenses 17 related to performance of duties. 18 AT LEAST 6 MONTHS BEFORE SUBMITTING A LEGISLATIVE PROPOSAL TO THE CALVERT COUNTY DELEGATION FOR INTRODUCTION AS A BILL 19 20 IN A SESSION OF THE GENERAL ASSEMBLY, THE BOARD SHALL: POST NOTICE OF THE PROPOSAL ON THE BOARD'S WEB 21**(I)** 22SITE; AND 23 (II)HOLD A PUBLIC HEARING ON THE PROPOSAL IN THE 24COUNTY. SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 2526 1, 2015.
