CHAPTER AN ACT concerning Judges' Retirement System - Membership, Accrual of Interest Benefits, and Reemployment FOR the purpose of clarifying that regular interest may not be paid on member contributions of certain members of the Judges' Retirement System under certain circumstances; providing that membership in the Judges' Retirement System for certain members ends under certain circumstances; clarifying the eligibility for a retirement allowance for certain members of the Judges' Retirement System who are retired by order of the Court of Appeals; establishing the eligibility for a retirement allowance for certain members of the Judges' Retirement System who are retired by order of the Court of Appeals; providing for the method of calculating a retirement allowance for certain members of the Judges' Retirement System who are retired by order of the Court of Appeals and have less than a certain amount of service credit; repealing a limitation on when a member may withdraw accumulated contributions
